Registration Form on Members' Interests

I have received the letter dated August 23 from the Secretariat. My reply to the relevant questions is as follows:

1. With regard to the issue concerning the shareholders of the Target Link Ltd., a property holding company, it has all along been my understanding that the company had issued two shares only, each of which (i.e. 50% of the shareholding) owned respectively by me and Mr Stanley NG Wing-fai, another member of the Democratic Party. Moreover, at that time, I had already transferred my one share (i.e. 50% of the shareholding), to the Democratic Party in the form of a trust.

According to Note (b) under the item "Shareholdings" in the declaration form:

* "Shareholdings" is defined as personal shareholdings and do not include shareholdings held by a Member in the capacity of a nominee shareholder.

And according to Note (c):

* It is the obligation of a Member to register interests under this category within his knowledge.

Out of my knowledge and understanding in the past, all along I considered that I was just holding one share, i.e. 50% of the shareholding, of Target Link in the capacity of a "nominee shareholder" rather than holding it physically. Moreover, I am not a remunerated director of the company and have never obtained any substantial benefits from it. For the abovementioned reasons, I did not make any declaration to the Legislative Council (LegCo) regarding the shareholding concerned.

Later it came to my knowledge that the number of shares issued by the company was in fact 100 and my 50% shareholding should be equivalent to 50 shares. After transferring one share to the Democratic Party, I still hold 49 shares. This shareholding is more than one per cent of the shares of the company, and hence subject to declaration to the LegCo.

In view of the above misunderstanding, I would like to make a belated declaration to the LegCo concerning my shareholding in the company. The declaration form is attached.

2. I do not have any control of the above company nor have more than 50% shareholding in it.
