**Discovery of Legionella bacteria in the new Central Government
Complex and the Legislative Council Complex**

Thank you for your letter of 6 January 2012.

Please be informed that for persons working at the LegCo Complex and who attend the Help Desk at Ruttonjee Hospital or other Accident & Emergency Department (A&E Department), they will be assessed into two groups –

- (a) for patients with frank respiratory symptoms, such as high fever or abnormal chest X-ray, they will be admitted for in-patient treatment and further investigation; and
- (b) for other patients with respiratory symptoms, fever, or especially with risk factors, even if the chest X-ray is clear, with respect to the patient's clinical condition, doctors will advise admission or consider offering appropriate antibiotics; get respiratory, blood or



urine samples for Legionnaires' Disease investigation; and arrange follow up assessment in one to two days' time. Asymptomatic persons attending the Help Desk at Ruttonjee Hospital or A&E Department will be given health education and other necessary information.

The Government will also keep the public informed of the laboratory results of water samples taken from various sites in the new Central Government Complex and the LegCo Complex once relevant information is available.
