## Reduce consumption of paper Opt to receive soft copies of documents

The Legislative Council ("LegCo") Secretariat provides soft copies of most meeting documents for Members via their Lotus Notes and other email accounts. Members can also access the soft copies of these documents at the LegCo website. They may choose to print meeting documents on a need basis.

2. To economize on the use of paper, many types of documents are already provided to Members in soft copy only. After a review by the Secretariat, starting from 7 December 2017, some additional types of documents will be included. These types of documents are basically those not for discussion at open meetings, such as minutes of Panel meetings and documents provided by the Administration which have been tabled at meetings or are i received after meetings. Members may wish to refer to **Appendix I** for details.

3. Other than the types of documents listed in Appendix I, hard copies of documents (including those which will be discussed at meetings) will continue to be provided to Members as requested. A table showing the types of documents of which the hard copies are provided to individual Members concerned is in **Appendix II** (Chinese version only).

4. We would like to appeal to Members to minimize the use of hardcopies of documents as far as practicable. The LegCo Commission attaches great importance to the implementation of effective measures to reduce paper consumption. The quantity of paper consumed by the Secretariat will be reported in the Secretary General's annual Environmental Report, which is annexed to the Commission's annual report.

5. A table giving information about the availability of the soft copies of various types of documents is in **Appendix III** (Chinese version only) (also serving as a **reply slip** for Members). Members are invited to critically review their need for hard copies of documents and indicate in the **reply slip** (**Appendix III**) the types of documents for which they no longer need the hard copies, and send it to the Secretariat on or before **15 December 2017** (**Friday**).
