Dear President Tsang,

I refer to your ruling on 14 February 2014 that I should not use insulting and offensive language about the Chief Executive of the HKSAR in a Council meeting.

You may have forgotten the earlier debate between us on the same topic where you failed to identify the relevant provision in the Rules of Procedures forbidding such remarks about the Chief Executive. I suggest you reading the attached correspondence to refresh your memory.

Rule 41(4) of the Rules protects only "members"; and by virtue of Rule 10(2), the protection is extended to "public officers". The Chief Executive is not a public officer; and therefore is in no better position than an ordinary citizen and not covered by Rule 41(4). Your ruling is unfounded and unparliamentary.

The following are examples that insulting and offensive language about the Chief Executive is always permissible:

- (1) On 10 December 2012, Hon James Tien suggested Leung obtained the office of Chief Executive HKSAR by deception.
- (2) On 16 October 2013, in a motion of non-confidence in the Chief Executive, insulting and offensive remarks are common found in the speeches speaking for the motion.

No matter how you dislike the remark "梁匪振英", negative remarks about the Chief Executive will not end.

Dear Kenneth,

Your letter dated 30 October 2013 refers.

I trust you are aware that the President has made no rulings in respect of the use of offensive and insulting language about the Chief Executive by some Members during the Chief Executive's Question and Answer Session on 17 October 2013, despite the requests by four other Members. In refusing to make a ruling, the President gave the following worth-noting remarks, "such languages are frequently used in Council meetings".

The President's letter of 17 October 2013 merely talks about his personal expectation of Members' behavior in Council meetings and his incorrect understanding of the Rules of Procedure, which do not constitute any rulings of points of order. Hence, the finality under Rule 44, as raised by you, is not applicable; or there would be no point to set up the Committee on Rules of Procedure as everything could be decided by the President arbitrarily.

I regret that in the discussion of what conduct and/or language are permissible in Council meetings, there has been no reference to the Rules of Procedure. Is it what we called "unparliamentary"?

Dear President Tsang,

I refer to your letter dated 23 October 2013.

Whereas there could be no doubt that you have to play your role as President in the conduct of the LegCo proceedings, it does not follow that you have unlimited or arbitrary power in doing so, more particularly:

- (1) You could only enforce the Rules of Procedure as they stand, and not as improvised by you from time to time, especially when you have absolutely no power so to do. Your addition of the expression "unparliamentary" conduct to the Rules of Procedure is meaningless as it is circuitous to describe any conduct as "unparliamentary" without resort to the Rules of Procedure as they stand;
- (2) You have not yet clarified how the Rules of Procedure could have covered the Chief Executive, which failure on your part points to the non-applicability of the Rules of Procedure to him. Your assumption of their applicability to the Chief Executive, if deliberate, implies an abuse of power on your part that you are re-writing or extending the Rules of Procedure without going through the requisite procedure.
- (3) Your power to conduct the meeting does not include the power to re-write or extend the Rules of Procedure as aforesaid, or there would be no need to specify "Members" in Rule 41(4) as it could be interpreted by you to cover anyone you like.
- (4) The fact that the Chief Executive was elected by 689 people is already very insulting and humiliating. Are you going to ban all references of 689 when Members address Mr. Leung in LegCo?

(5) Your reference to "immunity" is irrelevant as the context for its relevance could only be in circumstances where legal actions are contemplated or at least possible.

In the circumstances, it would be beneficial to you and to LegCo if you could in future demonstrate your correct understanding of the Rules of Procedure before sending letters like those dated 17th and 23rd October 2013 to Members so that no one needs to be misled by your errors.



Dear President Tsang,

I refer to your letter to all members of the Council dated 17 October 2013 regarding the language used by some Members at Chief Executive's Question and Answer Session on the same day.

For the purposes of the Rules of Procedure, the Chief Executive is <u>NOT</u> a public officer and therefore not entitled to the protection given to public officers under Rules 10(2) and 41(4). It follows that any offensive and insulting language about the Chief Executive which is not unparliamentary is permissible under the Rules.

Dignity of the Council will certainly be upheld when the era of universal suffrage comes.
