Information requested by the Bills Committee at its meeting held on 18 January 2001 regarding requirements of vessels carrying dangerous goods

Ocean-going Vessels

As stipulated in section 16 of the Merchant Shipping (Safety) (Dangerous Goods and Marine Pollutants) Regulation, Cap. 413 (Annex A), an ocean-going vessel carrying packaged dangerous goods is required to have on board a document of compliance (Annex B), issued by the Director of Marine or the competent authority of the country in which it is registered, that the spaces in which the dangerous goods are to be carried comply with the provisions of regulation 143 of the Merchant Shipping (Safety) (Fire Protection) (Ships Built On or After 1 September 1984) Regulations, Cap. 369 sub. leg. (Annex C). The provisions of regulation 143 follow those laid down in the International Convention for the Safety of Life at Sea 1974, including specific requirements in respect of the supply of water from the fire main, the provision of fire fighting equipment, ventilation system, and fire detection and fire alarm systems, the types and location of electrical equipment and wiring, insulation of bulkheads, etc.

Local Vessels

As stipulated in regulation 12(1) of the Dangerous Goods (Shipping) Regulations, Cap. 295 sub. leg. (Annex D), any vessel, be they used in navigation or not, trading exclusively within the waters of Hong Kong and required to be registered or licensed pursuant to the provisions of the Merchant Shipping Ordinance, Cap. 281, is required to obtain the written permission in respect of such vessel, i.e. a "declaration of fitness" (Annex E) from the Director of Marine for the conveyance of dangerous goods.

In accordance with regulation 12(3) of the Dangerous Goods (Shipping) Regulations, Cap. 295 sub. leg. (Annex D), the Director of Marine, before granting the permission, must be satisfied that the vessel is in all respects suitable and fit for the conveyance of dangerous goods and is adequately equipped with fire fighting appliances. In this regard, the Director will make reference to the set of requirements for ocean-going vessels as laid

down in regulation 143 of the Merchant Shipping (Safety) (Fire Protection) (Ships Built On or After 1 September 1984) Regulations, Cap. 369 sub. leg..




