I. Consideration of Committee Stage Amendments (CSAs) to the Securities and Futures Bill (SFB) and Banking (Amendments) Bill 2000 (BAB) proposed by the Administration

## (A) Outstanding CSAs from the Administration

#### Action

Members agreed that the Bills Committee would scrutinize the English version of CSAs proposed by the Administration. The LegCo Legal Service Division (LSD) was requested to examine the Chinese version of CSAs and follow up with the Law Draftsmen on drafting and other technical matters. In the event that there were unresolved issues, LSD would raise them at meetings.

- 2. The Bills Committee deliberated (Index of proceedings attached at the **Annex**).

- 3. The Administration undertook to take follow-up actions in respect of SFB and BAB as follows:
  - (a) to provide examples illustrating the use of clauses 106(3)(a)(iv) and 107(7)(c)(iv);
  - (b) to consider adding in clause 106(3)(a)(iv) the mental element that any intentional/reckless omission should be for the purpose of misleading or deceiving the misrepresentee;
  - (c) to replace "ground" with "excuse" in clause 178(1)(a);
  - (d) in connection with clause 178(1)(b) to provide examples in existing law where non-compliance with statutory requirements could be treated in the same manner as if the person had been guilty of contempt of court;

- (e) to continue discussion with the LegCo Legal Service Division regarding technical and drafting matters in respect of transitional provisions in Schedule 9;
- (f) to reassure during the resumption of Second Reading debate on SFB and BAB that clause 3 of BAB is not intended to expand the power of Hong Kong Monetary Authority (HKMA);
- (g) to provide further information comparing the penalties and offences of those provisions in existing law set out by the Administration (paragraph 9 of LC Paper No. CB(1) 789/01-02(01)) which are similar to clause 172(13); and
- (h) to follow up with the Judiciary Administrator regarding the suggestion of appointing administratively one of the Chairmen to oversee the operation of the Securities and Futures Appeals Tribunal (SFAT) in cases where additional tribunals are established (paragraph 14 of LC Paper No. CB(1) 789/01-02(01))

### (B) <u>CSAs to be moved by Members</u>

4. <u>Ms Margaret NG</u> indicated that she would propose to the Council to oppose the inclusion of clause 11, which provides the Chief Executive with the power to give written directions to SFC regarding the performance of its functions, in SFB. <u>Mr Henry WU</u> said that he was still considering whether he would move CSAs on the bills.

## II. Any other business

## Outstanding CSAs from the Administration

5. The Administration undertook to provide new CSAs or written responses to address members' concerns before 25 January 2002. Members agreed that if the new CSAs or written responses were acceptable to members, the Bills Committee would conclude its work.

(Post-meeting note: The outstanding CSAs provided by the Administration had been issued to members vide LC Paper Nos. CB(1) 971/01-02 and 1042/01-02 on 30 January and 7 February 2002 respectively.)

6. As the Administration intended to resume the Second Reading debate on the two Bills at the Council meeting on 13 March 2002, <u>members</u> agreed that the Bills Committee would submit its report to the House Committee on 22 February 2002. In view that a large number of subsidiary legislation which would be subject to negative

vetting of the Council would be made under the Securities and Futures Ordinance for implementation of the Ordinance, <u>members</u> also agreed to make recommendation for forming a subcommittee under the House Committee to allow members sufficient time in scrutinizing them.

7. The meeting ended at 11:30 am.
