 - (a) to replace the reference to "成立人" by "信託成立人" under the definition of "founder of the trust" in clause 299;
 - (b) to consider specifying in clause 300(4A) that particulars of exemptions granted under the clause would be available to the public in the form of an on-line record;
 - (c) to review the phrase "the last notification required to be given" in clause 304(7)(b)(i);
 - (d) to review if the reference to "regulations" in clause 337(1)(e) should further be clarified;
 - (e) to consider whether the words "for such purposes" should be moved from the end of clause 347(1) to before sub-clause(1)(a);
 - (f) to review the phrase "ceased to remain listed" in clause 369(2)(a)(i); and
 - (g) to review clause 390(2) and consider whether it is necessary to give SFC the rule-making power to prescribe transactions or activities to be dealt with under the Gambling Ordinance.
- 4. <u>Members</u> agreed to consider CSA on Parts XIII, XIV & XVII of and Schedules 1, 8 and 9 to SFB proposed by the Administration at the next meeting scheduled for Friday, 14 December 2001, at 8:30 am.
