Action

I. **Meeting with the Administration**

[LC Paper No. CB(2)2384/01-02(01)]

The Committee deliberated on the Administration's response to issues raised at the previous meeting [LC Paper No. CB(2)2384/01-02(01)] and the Administration's latest position on the proposed amendments to sections 25 and 25A of the Drug Trafficking (Recovery of Proceeds) Ordinance (Cap. 405) and Organized and Serious Crimes Ordinance (Cap. 455) (index of proceedings attached at Annex).

Administration's latest position regarding the proposed amendments to sections 25 and 25A of the Drug Trafficking (Recovery of Proceeds) Ordinance and Organized and Serious Crimes Ordinance

2. The Administration informed the Committee that it would amend the mental element regarding the reporting requirement of terrorist financing from "having reasonable grounds to suspect" to "suspect" in the United Nations (Anti-Terrorism Measures) Bill. In view of this development and for the sake of maintaining consistency in legislation, the Administration would withdraw its proposals to amend sections 25 and 25A of Cap. 405 and Cap. 455

respectively. It would move Committee Stage amendments (CSAs) to repeal sections 10 and 11 of Schedule 1 and sections 9 and 10 of Schedule 2 to the Bill.

- 3. Mr Eric LEE welcomed the Administration's decision to withdraw its proposals to amend sections 25 and 25A of Cap. 405 and Cap. 455 respectively. He said that since the introduction of the Bill in 2000, the Hong Kong Society of Accountants and the financial sector had done a lot in the area and issued many guidelines on the reporting of suspicious transactions. He hoped that it would not be necessary for the Administration to reintroduce the proposed amendments in the future. Mr NG Leung-sing also welcomed the Administration's decision, saying that it would help maintaining Hong Kong's position as a financial centre. He hoped that the Administration would consult the relevant sectors before any reintroduction of the proposed amendments. Other members present at the meeting raised no objection to the Administration's decision.
- 4. The Administration pointed out that similar proposed amendments to sections 25 and 25A of Cap. 405 and 455 would still be needed in future, pending the completion of the Financial Action Task Force on Money Laundering's (FATF) Review of its 40 Recommendations, which encompassed the possible change of the mental element in money laundering and reporting offences from "suspect" to "having reasonable grounds to suspect". A number of FATF members/jurisdictions had already adopted the lower mental element of "having reasonable grounds to suspect". In order to ensure the effectiveness of the law, Hong Kong would eventually need to adopt the same approach. In doing so, the Administration would no doubt consult the relevant sectors before putting legislative proposals to LegCo.

<u>Draft Committee Stage amendments to be moved by the Administration</u>

5. Assistant Legal Adviser 4 drew members' attention that there was inconsistency between the drafting of the Chinese and English versions of the CSAs to section 3(a) of Schedule 1 to the Bill in that there was no corresponding phrase in the English version for the phrase "已採取行動" in the Chinese version. The Administration undertook to consider revising the English version of the CSAs for the sake of maintaining consistency with the Chinese version and provide the CSAs for members' reference.

Legal aid for a defendant whose assets were subject to a restraint order

6. Regarding the eligibility of a defendant for legal aid, the Chairman said that the restrained assets of a defendant whose assets were subject to a restraint order should not be included in the computation of the financial resources of the defendant. He would consider raising the issue at meetings of the relevant

Panels, such as the Panel on Administration of Justice and Legal Services or the Panel on Security.

Legal privilege of a legal representative

7. At the request of the Committee, the Administration agreed that if CSAs relating to the protection of legal privilege of a legal representative were to be moved by the Administration to the United Nations (Anti-Terrorism Measures) Bill, it would move similar CSAs to relevant provisions in the Bill and provide the relevant CSAs for members' reference. The Chairman requested the Clerk to report developments on the matter, if any, to the Committee.

II. Any other business

- 8. The Committee agreed to recommend to the House Committee that the Second Reading debate on the Bill be resumed at the Council meeting on 10 July 2002, subject to the CSAs to be moved by the Administration. The Chairman informed the meeting that the deadline for giving notice to move CSAs at the Council meeting on 10 July 2002 would be 29 June 2002. The Committee would make a written report to the House Committee on 28 June 2002.
- 9. As the Committee had completed scrutiny of the Bill, <u>members</u> agreed that the next meeting originally scheduled for 28 June 2002 would be cancelled.
- 10. There being no other business, the meeting ended at 3:35 pm.
