I. Meeting with the Administration

[LC Paper Nos. CB(2)1485/01-02(01), CB(2)630/01-02(01) and CB(3)146/00-01]

The Committee deliberated on the Administration's response to the queries raised by the Assistant Legal Adviser 4 in his letters dated 6 and 11 December 2001 and the outstanding issues arising from the meeting on 7 December 2001 (index of proceedings attached at **Annex**).

2. <u>Members</u> noted that the Administration had devised new formulations for sections 7, 8, 16A and 16E. <u>The Administration</u> explained that the wording

of the relevant proposed provisions had been simplified but the power to combat cross-border gambling activities had been preserved. Members also noted that a new subsection (2) had been added to proposed section 16A to make it clear that proposed section 16A(1) would not apply if the bet in question could only be placed or was placed by a person outside Hong Kong. The Administration confirmed that it was not an offence to promote in Hong Kong bets which could only be placed outside Hong Kong.

- 3. <u>Some members</u> remained unconvinced that proposed provisions against Internet gambling could be effectively enforced. <u>The Administration</u> explained that the proposed provisions were targeted more at bookmakers than individual bettors and the Administration would not monitor online communication on the Internet. However, offshore bookmakers receiving bets placed from Hong Kong would face prosecution if they arrived in Hong Kong given sufficient evidence, and assistance would be sought from the overseas jurisdiction concerned in the investigation and prosecution process where necessary.
- 4. <u>Ms Audrey EU</u> was of the view that it was hard to accept that the Legislative Council was going to pass a Bill knowing that the Administration would not fully enforce it. She was concerned that since it was clearly a criminal offence in the Bill for a person to bet with an offshore bookmaker via the Internet, such a practice would send a negative message to the community that to commit a criminal offence was not a serious matter.
- 5. <u>Miss Margaret NG</u> also expressed reservations about the justifications for incorporating an extraterritorial element in the offences of "bookmaking" and "betting with a bookmaker". She pointed out that since it was not an offence for an overseas bookmaker to receive a bet placed from Hong Kong and for a person to bet with an offshore bookmaker under the existing legislation, the Bill would substantially expand the scope of the Gambling Ordinance. The Administration explained that the Bill only sought to uphold the integrity of the gambling policy in the light of the technological developments in communications and the increase in cross-border gambling activities.
- 6. To facilitate the work of the Bills Committee, the Administration was requested to -

Section 7 - Bookmaking

(a) provide information on enforcement experience through international co-operation against cross-border crimes committed through the internet;

Section 8 - Betting with a bookmaker

- (b) clarify whether it was an offence under amended section 8 for a person outside Hong Kong to place a bet with a bookmaker outside Hong Kong; and
- (c) reconsider whether it was necessary to specify the locations of the offenders under amended sections 7 and 8.
- 7. The Committee deliberated on the set of Committee Stage amendments (CSAs) proposed by the Administration as at 28 March 2002 (index of proceedings attached at **Annex**). The Administration was requested to -

Clause 2 - Interpretation

(a) make reference to the Chinese term of "on-line medium" used by jurisdictions where legislation was in Chinese;

New Section 2A - Gambling is unlawful

(b) reconsider whether the amendment of replacing "7" with "7(1) or (1A)" was necessary in section 3(7);

Clause 4 - Bookmaking

- (c) review the drafting of section 7(1)(b) to ascertain whether a person would commit an offence if he solicited in Hong Kong another person to bet outside Hong Kong;
- (d) ensure consistency in describing the person placing a bet with a bookmaker in the Bill;

Clause 8 - Part added

- (e) ensure consistency as an expression "an act is promoted or facilitated if" was used in new section 16A(2A) while a different expression "a person promotes or facilitates bookmaking or betting with a bookmaker if " was used in new section 16E(2); and
- (f) add the word "or" between new sections 16A(2A)(b)(v) and (vi).
