#### I. Confirmation of minutes

[LC Paper No. CB(2)1443/01-02]

The minutes of the meeting held on 7 December 2001 were confirmed.

#### II. Meeting with the Administration

2. The Committee deliberated on the Administration's response to the queries raised by members at the meeting on 3 April 2002 [LC Paper No. CB(2)1542/01-02(01)] (index of proceedings attached at **Annex**).

#### Section 2 - Interpretation

- 3. The Administration was requested to consider adding satellite and microwave transmission to the definition of "bookmaking" under section 2 as media through which the soliciting, receiving, etc. of a bet could be conducted.
- 4. To address members' concern that privacy rights of an individual might be infringed in the process of enforcement actions against Internet gambling, the Chairman and Mr SIN Chung-kai requested the Administration to explain clearly in writing the principles and internal guidelines for the Police to monitor on-line communications. The Chairman also asked the Administration to explain the actions which would be taken by the Police to enforce the proposed provisions against Internet gambling.

### Proposed amendments to sections 7 and 8 of the Gambling Ordinance

- 5. <u>Members</u> noted that the Administration considered that insofar as sections 7 and 8 were concerned, it was where the act (bookmaking or betting) took place which mattered, rather than the physical location of the offender. In the absence of express provisions, the standard interpretation was that the law only applied to an act occurring in Hong Kong.
- Ms Audrey EU said that if where the act took place was the primary 6. consideration for the establishment of an offence under the amended sections. she was concerned that where the act to place or receive a bet might be changed by way of a contract or some technological means. The Administration responded that there were so far no enforcement problems arising from implementation of sections 7 and 8 since the enactment of the Gambling Ordinance in 1977. The Court would have to consider the facts and circumstances in each case to determine whether the act was made in or outside Ms EU requested the Administration to elaborate on the Hong Kong. relationship between the physical location of a person and where the act (bookmaking or betting) took place in amended sections 7 and 8 by way of setting out examples in which a person was physically in Hong Kong but his act to place or receive a bet was outside Hong Kong, and vice versa.
- 7. The Chairman was of the view that since the phrase "whether the bet is received within or outside Hong Kong" was proposed to be added to section 8 (Betting with a bookmaker), it should be clearly specified in the provision that a person who betted with a bookmaker would commit an offence under amended section 8 only if he so betted in Hong Kong. The Administration did not consider it appropriate or necessary to specify the physical location of the person or the act of betting under the amended section 8 because the normal interpretation at common law was that an offence provision only applied to an act occurring in Hong Kong unless expressly stated otherwise. The proposed amendment might also have implications for the interpretation of other

provisions of the Gambling Ordinance. <u>The Chairman</u> requested the Administration to provide a legal analysis setting out the provisions which would be affected if it was clearly specified that a person who betted with a bookmaker would commit an offence under amended section 8 only if he so betted in Hong Kong.

8. Ms Cyd HO considered that proposed amendments to section 8 would substantially expand the scope of the Gambling Ordinance and have widespread implications on human rights and privacy issues. She said that since the Administration had all along claimed that the proposed provisions were targeted at bookmakers rather than an individual who placed a bet, she might consider proposing to delete section 8 from the Ordinance. She requested the Assistant Legal Adviser 5 to provide an analysis of the possible implications on the operation of the Gambling Ordinance if section 8 was deleted.

#### Section 16D - Responsibilities of owners, tenants, etc. under section 16A

9. The Administration was asked to consider providing an exemption clause similar to proposed new section 16E(5) under proposed new section 16D.

#### III Any other business

- 10. The Committee would hold its next meeting on Friday, 19 April 2002 at 10:45 am to consider the Committee Stage amendments proposed by the Administration.
- 11. There being no other business, the meeting ended at 12:40 pm.
