I. Confirmation of minutes of meetings

(LC Paper Nos. CB(2) 719/01-02 and CB(2) 720/01-02)

The minutes of the meetings on 15 and 29 November 2001 were confirmed.

II. Meeting with the Administration

(LC Paper Nos. CB(2)747/01-02(01)-(02) and CB(2)832/01-02(01)-(03))

- 2. The Committee deliberated (index of proceedings attached at **Annex A**).
- 3. On LC Paper Nos. CB(2)832/01-02(01) and (02), the Committee noted the following information provided by the Administration at the meeting -
 - (a) There were at present 539 clubs certified under the Clubs (Safety of Premises) Ordinance. Of the 85 certified clubs providing karaoke activities, 24 were reported to have ancillary karaoke activities, i.e. karaoke activities were only an optional extra to the main activities of the clubs;
 - (b) While 6 of the 24 certified clubs would not meet the exemption criteria proposed by the Administration, the licensing authority could exercise discretion in their favour on a case-by-case basis.
- 4. The Administration was requested to provide the following information to facilitate the work of the Committee -
 - (a) in regard to the building and safety requirements in karaoke establishments (KE) in Japan and Taiwan (as set out in Annex to LC Paper No. CB(2)832/01-02(03)), to provide further information -
 - (i) for Japan and Taiwan, whether partitions of corridor providing means of escape from the cubicles were required to have a fire resistance period of 1 hour;
 - (ii) for Japan and Taiwan, what specific materials were required to be used for partitions of corridor;

- (iii) for Japan, what was the exact meaning of the requirement "partition walls should reach above-ceiling space";
- (iv) for Japan, whether any requirement was imposed on the width of the corridor providing means of escape from the cubicles for floors with area less than 200 m²; and
- (b) to advise how anonymous objections raised under clause 5(3)(b) would be handled by the licensing authority, making reference to the experience of other licensing schemes.
- 5. The Committee agreed that certified clubs providing karaoke activities should be consulted on the proposed regulatory control after the Administration had provided information on the factors to be taken into consideration by the licensing authority in granting exemption from applying for a karaoke licence or permit under clause 3(1)(e).
- 6. <u>Mr Andrew WONG</u> said that he would not support the resumption of Second Reading debate of the Bill. He would consider whether he would move a motion to request the Committee to take a vote on the matter at the meeting on 24 January 2002.

II. Date of next meetings

- 7. The next two meetings had been scheduled for 14 January 2002 at 4:30 pm and 24 January 2002 at 2:30 pm respectively.
- 8. There being no other business, the meeting ended at 4:40 pm.
