## I. Confirmation of minutes of meetings

(LC Paper Nos. CB(2)957/01-02, CB(2)1047/01-02, CB(2)1048/01-02 and CB(2)1053/01-02)

The minutes of the meetings held on 21 December 2001 and 10 January, 14 January and 24 January 2002 were confirmed.

#### II. Meeting with the Administration

(The Bill and LC Papers Nos. CB(2)1044/01-02(02) and (03) and CB(2)1169/01-02(01))

2. The Committee deliberated (index of proceedings attached at **Annex A**).

#### LC Paper No. CB(2) 1169/01-02(01)

- 3. The Committee noted that the Administration would propose the following amendments to narrow the scope of applicability of the Bill -
  - (a) deleting the existing clauses 3(1)(a) and (b) and including the "3 rooms and 30 square metres" exemption provision in clause 3 as new clause 3(1)(a);
  - (b) deleting clause 4(4); and
  - (c) revising clause 3(1)(e) to read "exempted by the licensing authority, by order in writing that is for the time being in force, where, for reasons connected with the situation, means of ingress or egress, design, construction, size or equipment, installations or facilities therein, he is satisfied that the safety of a person using a karaoke establishment will not be adversely affected."

- 4. Mr LAU Kong-wah, Mr Tommy CHEUNG and Mr Howard YOUNG expressed reservations about the "3 rooms and 30 square metres" exemption provision. They considered that the proposed exemption criteria still rendered the scope of control of karaoke establishments (KE) under the Bill too wide. Mr LAU Kong-wah opined that even with the proposed exemption criteria, clubhouses of private residential estates might still be caught by the Bill. Having regard to the policy intent of the Bill, he proposed that certified clubhouses of private residential estates, which had met general fire safety requirements under the relevant Ordinances governing such premises, should be exempted under the Bill. The Administration reiterated that clubhouses not meeting the proposed exemption criteria could apply for exemption under clause 3(1)(e) on a case-by-case basis, having regard to the merits of each case.
- Mr Tommy CHEUNG considered that the Bill should only apply to 5. bone fide KEs, i.e. "karaoke box" with enclosed-cubicle layout and operated for the purpose of karaoke by way of trade or business. Mr Howard YOUNG suggested that the Administration should consider exempting premises where the karaoke activity occurred in rooms which were not accessed through long and narrow corridors from the application of the Bill. The Administration responded that it would be extremely difficult, if not impossible, to translate into precise legal wording of countless possible layouts and scenarios within There were also technical difficulties in defining the premises of KEs. structures such as "corridors". The Administration also pointed out that if the licensing authority was satisfied that the safety of a person using a KE would not be adversely affected, it could waive in writing wholly, partly or conditionally the requirements of any regulation in respect of that KE under clause 20(3).
- 6. <u>The Chairman</u> suggested that the Administration should provide examples in the future Guide for Application for KE Licence/Permit as illustration of the types of premises which could be exempted under the Bill. <u>The Administration</u> agreed to consider the suggestion.
- 7. Mr Andrew WONG reiterated his stance that he would not support the resumption of Second Reading debate of the Bill as it was fundamentally wrong for the Administration to introduce a bill for the regulatory control of KEs. He pointed out that what had aroused public concern was not karaoke activity per se, but the high risk of fire in premises with closed -cubicle layout. He was of the view that the Administration should review the adequacy of the fire safety standards imposed on compartmentalised premises instead of introducing a licensing regime for KE.
- 8. On the draft standard conditions for KE licences or permits (at Annex D to LC Paper No. CB(2) 1169/01-02(01)), the Administration advised that the criteria for determining the maximum number of persons to be allowed in KE premises at any one time (including staff) would be based on the Code of

Practice for Provision of Means of Escape in Case of Fire published by the Director of Buildings. The relevant requirements set out in the Code of Practice were as follows -

- (a) customers
  - 1 m<sup>2</sup>/person, calculated on the aggregate area of entertainment rooms, lounge and dining area; and
  - 0.75 m<sup>2</sup>/person in dancing area and reception area.
- (b) staff one per 20 customers or 4.5m<sup>2</sup>/person in kitchen/food preparation area, whichever was the greater.

<u>Members</u> noted that the floor area of passages would not be taken into account in calculating the population of a KE.

9. Mr Tommy CHEUNG considered that the requirement to stipulate the population of a KE in the licence or permit would not be conducive to the business environment. He pointed out that although the population of the premises concerned would be assessed for the purpose of determining the provision of means of escape in the course of processing an application for a restaurant or liquor licence, the maximum number of persons allowed in the premises was not stipulated as a condition of the licence.

#### **III.** Date of next meetings

10. The Committee agreed to hold the next two meetings on 7 March 2002 at 4:30 pm and 12 March 2002 at 8:30 am respectively.
