## I. Confirmation of minutes of meetings

# II. Meeting with the Administration and Karoke Requirements Concern Group

(LC Paper Nos. CB(2)1547/01-02(01) and 1585/01-02(01))

- 2. The Committee deliberated (index of proceedings attached at **Annex A**).
- 3. The Karaoke Requirements Concern Group (the Concern Group) introduced its written submission (LC Paper No. CB(2)1547/01-02(01)). While the Concern Group was in support of the fire safety and building safety

requirements, it proposed that the proposed licensing regime for karaoke establishments (KE) should be replaced by a procedure under which the granting of a licence or permit for the operation of a KE would take the form of an endorsement attached to a food licence or a certified clubhouse licence, as the case might be.

- 4. The Committee considered the views of the Concern Group and the Administration (LC Paper No. CB(2)1585/01-02(01)) on the proposal.
- 5. To facilitate further discussion of the Committee, the Concern Group was requested to provide -
  - (a) information on the statutory regulatory scheme for KEs in Japan and Taiwan; and
  - (b) an estimated breakdown of the monthly income of a KE, e.g. charges for the use of karaoke boxes and charges for food and drinks (including alcoholic drinks).

- 7. There being no other business, the meeting ended at 10:35 am.
