#### I. Confirmation of minutes of meeting

(LC Paper Nos. CB(2)1580&1581/01-02)

The minutes of the meetings on 7 and 20 March 2002 were confirmed.

#### II. Meeting with the Administration

(The Bill and LC Papers Nos. CB(2)1585/01-02(01) and (2))

- 2. The Committee deliberated (index of proceedings attached at **Annex A**).
- 3. <u>Hon Howard YOUNG</u> said that the trade was very concerned about the power of the licensing authority to refuse to grant or renew a licence or permit based on the considerations of "public interest". The Administration should appreciate the fact that the trade had to make substantial investments for operating a karaoke establishment (KE) and the absence of criteria for assessing "public interest" would render the operation of a licensed KE uncertain. He questioned the need for the Bill to impose various regulatory controls on KE which were already provided for under various Ordinances, other than those relating to fire and building safety.
- 4. <u>Hon Howard YOUNG</u> further said that the trade also objected to clause 12(2) which provided that the licensing authority's decision that was appealed against would not be suspended in its operation if the licensing authority was of the opinion that the suspension of the decision would be contrary to the public interest.
- 5. The Administration was requested to respond in writing to the following issues to facilitate the work of the Committee -
  - (a) On clause 10(iv) and (v), to consider
    - (i) the Chairman's view that sub-clauses (iv) would give the licensing authority too much power as it could revoke the licence or permit of a KE on the basis that the KE was no longer located in an area suitable for the operation of KE during the validity period of its licence or permit;

- (ii) the Chairman's suggestion that clause 10(v) should be deleted as it overlapped with clause 10(iv);
- (iii) to provide examples where the licensing authority might invoke clause 10 (a) (d) in respect of circumstances set out in clause 10 (iv) & (v); and
- (b) to confirm whether the existing Resource Centre under the Food and Environmental Hygiene Department providing advisory services and restaurant licensing-related information to applicants could also provide the same advisory services for KE applicants.
- 6. <u>The Chairman</u> reminded the Administration to provide -
  - (a) response to issues raised at the meetings on 20 March and 8 April 2002;
  - (b) draft Committee Stage amendments proposed by the Administration at previous meetings; and
- (c) updated draft Karaoke Establishments (Licensing) Regulations as soon as possible for members' consideration.

#### III. Date of next meeting

- 7. The next meeting would be held on 2 May 2002 at 4:30 pm. <u>The Clerk</u> would issue a circular to inform members of dates of further meetings and to confirm their attendance.
- 8. There being no other business, the meeting ended at 12:10 pm.
