I. Confirmation of minutes of meeting

(LC Paper No. CB(2)2006/01-02)

The minutes of the meeting on 2 May 2002 were confirmed.

II. Meeting with the Administration

(The Bill and LC Paper Nos. CB(2)2007/01-02(01) and CB(2)2103/01-02(01))

- 2. The Committee deliberated (index of proceedings attached at **Annex A**).
- 3. The Administration agreed that the Police would consider strengthening their general guidelines on seizure of articles to state that the power of seizure should be exercised in a cautious and reasonable manner. The Chairman requested the Administration to provide a copy of Chapter 44 of the Force Procedures Manual for members' reference. He suggested that considerations should be given to including in the guidelines whether the seizure was really necessary, the quantity of items which should be seized and whether the quantity seized would have a punitive effect. He further suggested that the subject should be referred to the Panel on Security for follow-up discussion. Members agreed.
- 4. The Administration was requested to respond in writing to the following issues to facilitate the work of the Committee -
 - (a) to consider replacing the reference to "public interest" in clause 5(3)(c) by "fire safety, building safety and public safety";
 - (b) to consider the Assistant Legal Adviser's suggestion of revising clause 13(1)(ii) to stipulate that the exercise of power under the clause was only for the purpose of ensuring compliance with the provisions of the Bill and with the licensing conditions;
 - (c) to justify the need to confer on the Police the power of seizure for evidence in support of revocation or suspension of a permit or licence under clause 13(1)(iii);
 - (d) to provide internal instructions issued by the Police on the return of seized property and to provide examples of Ordinances which included provisions also on the return of seized property. (A member suggested that reference should be made to the Public Health and Municipal Services Ordinance and the Drug Dependent Persons Treatment and Rehabilitation Centres (Licensing) Ordinance); and
 - (e) to consider revising clause 15(6)(b) proposed in the draft Committee Stage amendments (CSAs) to the effect that the licensing authority should <u>as soon as practicable</u> within 28 days after receiving a request for a discharge of the closure order

inform a KE operator of the reasons why the closure order could not be discharged.

- 5. The Administration agreed to move an additional CSA to delete "unless the owner of the apparatus, equipment or any other article, satisfies the court that there is special and exceptional reason not to order forfeiture, such as that the apparatus, equipment or other article had been stolen and the theft reported to the police as soon as practicable; but ownership of itself of any apparatus, equipment or other article by a person other than the person convicted or financial hardship to any person shall not be special and exceptional reason" in clause 19.
- 6. The Administration agreed to provide the updated draft Karaoke Establishments (Licensing) Regulation for members' reference before the next meeting.

III. Date of next meeting

- 7. The next meeting would be held on 31 May 2002 at 10:45 am. The <u>Clerk</u> would fix the dates of two additional meetings to complete scrutiny of the proposed CSAs. <u>Members</u> agreed that the Second Reading debate on the Bill should be resumed on either 3 or 10 July 2002.
- 8. There being no other business, the meeting ended at 12:45 pm.
