I. Meeting with the Administration

(LC Paper Nos. CB(2)2118/01-02(02), CB(2)2180/01-02(01) and CB(2)2201/01-02(01))

The Committee deliberated (index of proceedings attached at **Annex A**).

- 2. The Administration took members through the following additional draft Committee Stage amendments (CSAs) -
 - (a) to amend the proposed clause 3(1A) by adding an additional factor of "proportion of area for conducting karaoke activity";
 - (b) to delete clause 5(3)(c);
 - (c) to amend clause 13(1) to stipulate that the power under the clause was to be exercised for the purpose of ensuring compliance with the provisions of the Bill and with the licensing conditions;
 - (d) to delete the new clause 13(3)(b) proposed in the draft CSAs;
 - (e) to revise clause 15 to the effect that the licensing authority would, as soon as practicable after receiving a request for discharge of closure order, notify the applicant of any outstanding matter that needed to be remedied; and
 - (f) to amend clause 20(4) to make the penalty provision under this clause the same as that under the proposed clause 16(5).

(The above draft CSAs had been incorporated in the updated version [as at 4 June 2002] of draft CSAs to be moved by the Administration which was tabled at the meeting.)

- 3. The Administration agreed to -
 - (a) explain that restaurants would be covered by the proposed clause 3(1A) when the Second Reading debate on the Bill was resumed; and
 - (b) include such explanations in the information pamphlets on licensing requirements.
- 4. The Administration was requested to respond in writing to the following issues to facilitate the work of the Committee -
 - (a) to add express provisions to the Bill to provide for the return of seized property within 6 months after the date of the seizure,

- unless prosecution against an offence in respect of the seized property was instituted within the 6 months; and
- (b) to amend the proposed clause 15(5)(b) to stipulate that the licensing authority must, as soon as practicable and within 28 days after receiving the request for discharge of closure order, notify the applicant of any outstanding matters that required to be remedied.

II. Date of next meeting

- 5. <u>Members</u> agreed that the next meeting would be held on 10 June 2002 at 4:30 pm instead of 14 June 2002 as originally scheduled. <u>The Clerk</u> would remind members to provide a copy of their proposed CSAs before the next meeting for circulation to members for their information. <u>The Assistant Legal Adviser</u> would provide a marked-up copy of the Bill showing the additional draft CSAs proposed by the Administration before the next meeting.
- 6. There being no other business, the meeting ended at 9:50 am.
