The Committee deliberated (Index of proceedings attached at **Annex**).

- 2. The Administration was requested to provide information on the following -
 - (a) to explain the rationale for appointing "a person", instead of the office holder, as "a corporation sole with perpetual succession".
 - (b) to advise whether the present drafting of the new section 3(2) and (3) could achieve the intended legal effect that the office holder, i.e. The Ombudsman, would be appointed as a corporation sole.
 - (c) to consider whether the Ombudsman should be re-appointed for not more than 1 further period of 5 years.
 - (d) to consider whether the emoluments and terms of employment of the Ombudsman and his/her staff should be determined by a management committee instead of the Chief Executive, and whether the broad principles of administrative arrangements should be specified in the Bill.
 - (e) to define clearly the functions of "Advisers".
 - (f) to introduce express provisions in the Bill to prevent conflict of interest and to clearly reflect the segregation of the mediation and investigation functions.

Action

- (g) to consider whether the criteria for determining which complaint could be dealt with by mediation could be specified in the Bill.
- (h) to specify the qualifications of mediators in the Bill.
- (i) to provide information on the current mechanism, together with past years' statistics, in dealing with appeals and complaints on the outcome of mediation/investigation conducted by staff of the Ombudsman.
- 3. The Committee agreed to hold the next meeting on 16 July 2001.
- 4. There being no other business, the meeting ended at 12:30 p.m.
