I. Briefing by the Clerk to Bills Committee and Assistant Legal Adviser and work plan of the Bills Committee

(LC Paper Nos. CB(2)1352/01-02(01) and (02); LS69/01-02)

<u>The Clerk to Bills Committee and Assistant Legal Adviser</u> briefed members on the above-referenced papers prepared for members' reference.

- II. Meeting with the Administration and the Law Society of Hong Kong (LC Paper No. CB(2)1352/01-02(04) letter dated 14 March 2002 from the Law Society of Hong Kong)
- 2. An article published in <u>Hong Kong Lawyer</u> (March 2001) on "Proposed Alternative Disciplinary Procedure" and a "list of offences which may be dealt with by means of an intermediate sanction" provided by the Law Society were tabled at the meeting (circulated under LC Paper No. CB(2)1395/01-02(01) and (02) after the meeting).
- 3. The Committee deliberated (index of proceedings attached at **Annex**).

Part XIV of the Bill (Amendments to Legal Practitioners Ordinance)

- 4. <u>Members</u> suggested that the Law Society should inform its members and solicit their views on the proposed alternative disciplinary procedure which provided for the summary disposal of complaints by the Tribunal Convenor of the Solicitors Disciplinary Tribunal (SDT) by way of a fixed penalty system.
- 5. <u>Ms Audrey EU and Ms Emily LAU</u> opined that the implementation of the proposed fixed penalty system should not lose sight of the need to preserve transparency and protect the public's right to know relating to breaches committed by legal practitioners.
- 6. The Law Society explained that the proposed disciplinary procedure was only intended to deal with minor technical breaches not involving dishonesty, without having to proceed to a full hearing of the SDT. Offence cases of a more serious nature and persistent offenders would be referred to the SDT. Also, under the Legal Practitioners Ordinance, on application by the solicitor and on an order made by the SDT or the Court of Appeal, the Law Society might not publish a summary of the findings of a SDT and the name of the solicitor who was the subject of the findings in any publication produced by the Society.
- 7. The Law Society also informed members that a total of 168 letters of disapproval had been issued by the Society to practitioners in the year 2000, as compared to 118 in the year 1999. Of the 168 letters of disapproval, 37 came within the scope of the proposed disciplinary procedure. The remaining 131 letters of disapproval involved trivial and minor complaints against solicitors. The Law Society would review and finalize the list of the offences which might be dealt with by the proposed disciplinary procedure.
- 8. The Bills Committee requested the Law Society to provide a written reply -
 - (a) to explain the scope and categories of breaches suitable for summary disposal by the Tribunal Convenor of the SDT under the proposed alternative disciplinary procedure (clauses 108 and 109);
 - (b) to explain how the proposed alternative disciplinary procedure would operate (e.g. the mechanism for fixing the level of penalty and the details intended to be laid down in the rules to be made by the Council of the Law Society etc);
 - (c) having regard to the views expressed by some members of the Bills Committee, to explain whether the operation of the alternative disciplinary procedure would address the need to enhance transparency and protect the public's right to know, e.g. in the case

- of a complaint lodged by a member of the public against a solicitor;
- (d) in view of the wide scope of proposed sections 9A(1A) and (1B), to review whether the drafting reflected the purpose of the proposed alternative disciplinary procedure (clause 108);
- (e) to comment on whether the reference to "shall be remunerated by the Society" in the proposed section 9(6) should be amended to "may be remunerated by the Society" (clause 107);
- (f) to explain the conditions to be prescribed by the Council of the Law Society for issuing a practising certificate (clause 105).
- 9. The Bills Committee also requested the Administration -
 - (a) having regard to the last paragraph of page 2 of the Law Society's submission dated 14 March 2002, to explain the policy intent of transferring to the Council of the Law Society the powers of the Chief Justice to prescribe grounds for refusal to issue a practising certificate and conditions that may be attached to a practising certificate (clause 105 of the Bill);
 - (b) to consider whether the reference to "shall be remunerated by the Society" in proposed section 9(6) should be amended to "may be remunerated by the Society" (clause 107); and
 - (c) in view of the wide scope of proposed sections 9A(1A) and (1B), to review whether the drafting reflects the purpose of the proposed alternative disciplinary procedure (clause 108).
