I. Confirmation of minutes of meeting

(LC Paper No. CB(2)1451/01-02)

The minutes of the meeting held on 8 March 2002 were confirmed.

II. Meeting with the Administration

2. <u>The Committee</u> deliberated (index of proceedings attached at **Annex**).

Part XIV of the Bill (Amendments to Legal Practitioners Ordinance (The Bill, marked-up copy of the Bill, LC Paper Nos. CB(2)1352/01-02(04), 1453/01-02(01) and 1455/01-02(01))

- 3. <u>Members</u> noted that the Secretariat had invited comments on the Bill from interested parties through the LegCo's website. <u>The Chairman</u> said that she would also consult members of the legal profession on the Bill in her capacity as the LegCo Member representing the Legal Functional Constituency.
- 4. <u>The Committee</u> examined Part XIV of Bill clause-by-clause.
- 5. <u>The Committee</u> requested the Administration -

Clause 105

(a) to clarify the difference in role between "the Society" and "the Council" in proposed section 6(5) of the Legal Practitioners Ordinance;

Clause 108

- (b) to consider whether the element of "dishonesty" should be included in proposed section 9A(1B);
- (c) to improve the drafting of proposed section 9A(1B)(a) with a view to removing the ambiguity of the word "deliberate";

Clause 109

(d) to clarify the scope of the term "any person affected" in proposed section 9AB(6);

Clause 126

- (e) to propose a draft Committee Stage amendment -
 - (i) to amend the new section 40A(4) of the Ordinance to replace the term "Chief Justice" with "Chief Judge";
 - (ii) to amend the new section 40E(6) of the Ordinance along the line of clause 105 so that the power of the Chief Justice under the subsection would be transferred to the Society of Notaries; and
- (f) to explain why section 3 of the Legal Practitioners (Amendment) Ordinance (27 of 1998) had yet to come into operation.
- 6. <u>The Administration</u> was requested to consult the Law Society on items (a) to (d) and the Society of Notaries on item (e) above in preparing its reply for the consideration of the Committee.

Part V of the Bill (Marital Rape and Related Sexual Offences)

7. The Chairman pointed out that a major view expressed in previous discussions of the Panel on Administration of Justice and Legal Services on the issue of marital rape was that the most urgent task of a legislative amendment exercise was to remove the existing uncertainty in the law so as to make it clear that marital rape was an offence. She considered that rather than seeking to deal with other related sexual offences at the same time as proposed in the Bill, hence making the amendment exercise far more complicated, a more simplistic approach to deal only with marital rape would suffice at this stage. In her opinion, the problems associated with other related sexual offences could be addressed at a later stage. Members generally shared her view.

- 8. <u>Ms Emily LAU</u> opined that should the Administration agree to deal with marital rape first, it should follow up with a review of other related sexual offences in due course. She added that the protection of victims of sexual offences should be the paramount concern.
- 9. <u>Senior Government Counsel (Prosecutions Division)</u> said that the existing sexual offences provisions in the Crimes Ordinance required modernization and a full review. He considered that there might be merits in the Chairman's proposal to proceed with the law amendment exercise by phases.
- 10. <u>The Administration</u> was requested to advise on its position on the Chairman's proposal to adopt a "minimalist" approach to deal only with the issue of marital rape at the present stage, leaving the amendments to other related sexual offences provisions to be considered as appropriate at a later stage, and explain the implications of this proposal, if any.
