### Members' Motions

### Rental subsidy

Hon Albert HO moved the following motion and addressed the Council:

That this Council urges the Government to formulate a rental subsidy policy, whereby rental subsidies are offered to eligible families which have been on the Waiting List for public housing for a period of time.

Question on Hon Albert HO's motion proposed.

The President stated that Hon Frederick FUNG would move an amendment to the motion. In accordance with the Rules of Procedure, the motion and the amendment would be debated together in a joint debate.

Hon Frederick FUNG moved the following amendment to Hon Albert HO's motion and addressed the Council:

To delete "of time" from "Waiting List for public housing for a period of time" and substitute with "exceeding the average waiting time for public rental housing, as pledged by the Government, until public rental housing units are allocated to them".

Question on Hon Frederick FUNG's amendment to Hon Albert HO's motion proposed.

Three Members spoke on the motion and the amendment.

At 5:00 pm, the President's Deputy took the chair during the temporary absence of the President.

Another 10 Members spoke on the motion and the amendment.

Hon Albert HO spoke on the amendment.

The Secretary for Housing spoke on the motion and the amendment.

At 6:00 pm, the President resumed the chair.

Question on Hon Frederick FUNG's amendment to Hon Albert HO's motion put.

Hon Albert HO claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 25 were present, six were in favour of the amendment, 17 against it and two abstained; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 27 were present, 16 were in favour of the amendment, nine against it and one abstained. (Voting record in Appendix I.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon Albert HO replied.

Question on Hon Albert HO's motion put.

Hon Albert HO claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 25 were present, six were in favour of the motion, 18 against it and one abstained; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 27 were present, 16 were in favour of the motion and 10 agaist it. (Voting record in Appendix II.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the motion was negatived.

# Extending the effective period of concessionary duty rate for ultra low sulphur diesel

Hon Mrs Miriam LAU moved the following motion and addressed the Council:

That this Council urges the Government to extend the effective period of the concessionary duty rate of \$1.11 per litre for ultra low sulphur diesel (ULSD) to 31 December 2001, and to expeditiously conduct a review before deciding on an appropriate duty level for ULSD for the year 2002.

Question on Hon Mrs Miriam LAU's motion proposed.

The President stated that Hon Fred LI would move an amendment to the motion. In accordance with the Rules of Procedure, the motion and the amendment would be debated together in a joint debate.

Hon Fred LI moved the following amendment to Hon Mrs Miriam LAU's motion and addressed the Council:

To add "devise a regulatory mechanism to prevent oil companies from reaping profits through the concessionary duty rate; at the same time, the Government should" after "31 December 2001, and to".

Question on Hon Fred LI's amendment to Hon Mrs Miriam LAU's motion proposed.

11 Members spoke on the motion and the amendment.

Hon Mrs Miriam LAU spoke on the amendment.

The Secretary for the Treasury spoke on the motion and the amendment.

Question on Hon Fred LI's amendment to Hon Mrs Miriam LAU's motion put and agreed it.

Hon Mrs Miriam LAU replied.

Question on Hon Mrs Miriam LAU's motion as amended by Hon Fred LI put and agreed to.
