Hong Kong Science and Technology Parks Corporation Bill Intellectual Property (Miscellaneous Amendments) (No.2) Bill 2000

The Bills were read the first time and ordered to be set down for Second Reading pursuant to Rule 53(3) of the Rules of Procedure.

Second Reading

Hong Kong Science and Technology Parks Corporation Bill Intellectual Property (Miscellaneous Amendments) (No.2) Bill 2000

The Secretary for Commerce and Industry moved the Second Reading and addressed the Council on each of the above two Bills.

Question on the Second Reading proposed. The President stated that in accordance with Rule $54\,(4)$ of the Rules of Procedure, the debates on the above Bills were adjourned and the Bills were referred to the House Committee.

Adaptation of Laws Bill 2000

Resumption of Second Reading debate

The debate on the Second Reading which had been moved on 8 November 2000 resumed.

Hon Margaret NG, Chairman of the Bills Committee on Adaptation of Laws Bill 2000, addressed the Council on the Report of the Bills Committee on the Bill.

The Chief Secretary for Administration replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a Committee of the whole Council.

Committee Stage

The Council went into Committee and considered the Adaptation of Laws Bill 2000.

Question that clauses 1, 2 and 3 stand part of the Bill proposed, put and agreed to.

Question that schedules 1, 2 and 3 stand part of the Bill proposed, put and agreed to.

The Council then resumed.

Third Reading

The Chief Secretary for Administration reported that

the Adaptation of Laws Bill 2000

had passed through the Committee without amendment. She moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Dutiable Commodities (Amendment) Bill 2000

Resumption of Second Reading debate

The debate on the Second Reading which had been moved on 8 November 2000 resumed.

Hon James TO, Chairman of the Bills Committee on Dutiable Commodities (Amendment) Bill 2000, addressed the Council on the Report of the Bills Committee on the Bill.

Five Members spoke on the Bill.

The Secretary for the Treasury replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a Committee of the whole Council.

Committee Stage

The Council went into Committee and considered the **Dutiable** Commodities (Amendment) Bill 2000.

Question that clause 2 stand part of the Bill proposed, put and agreed to.

Question that clause 1 stand part of the Bill proposed.

The Secretary for the Treasury moved amendments to clause 1 and addressed the Committee.

Question on the amendments put and agreed to.

Question that clause 1, as amended, stand part of the Bill proposed, put and agreed to.

The Council then resumed.

Third Reading

The Secretary for the Treasury reported that

the Dutiable Commodities (Amendment) Bill 2000

had passed through the Committee with amendments. She moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

<u>Motions</u>

<u>Proposed resolution under the Basic Law of the Hong Kong Special</u> <u>Administrative Region of the People's Republic of China</u>

The Chief Secretary for Administration moved the following motion and addressed the Council:

Resolved that the appointment of the Honourable Mr. Justice Arthur LEONG Shiu-chung as the Chief Judge of the High Court be endorsed.

Question on the motion proposed.

Three Members spoke on the motion.

The Chief Secretary for Administration replied.

Question on the motion put and agreed to.

Proposed resolution under the Dutiable Commodities Ordinance

The Secretary for the Treasury moved the following motion and addressed the Council:

Resolved that the Dutiable Commodities Ordinance be amended, in Part III of Schedule 1 -

- (a) in paragraph 1A(a), by repealing "31 December 2000" and substituting "30 June 2001";
- (b) in paragraph 1A(b), by repealing "1 January 2001" and substituting "1 July 2001".

Question on the motion proposed.

Four Members spoke on the motion.

The Secretary for the Treasury replied.

Question on the motion put and agreed to.

<u>Proposed resolution under the Pneumoconiosis (Compensation)</u> <u>Ordinance</u>

The Secretary for Education and Manpower moved the following motion and addressed the Council:

Resolved that, with effect from 1 January 2001, the First Schedule to the Pneumoconiosis (Compensation) Ordinance be amended, in Part VI, by repealing "\$16,000" and substituting "\$35,000".

Question on the Secretary for Education and Manpower's motion proposed.

The President stated that Hon LEE Cheuk-yan would move an amendment to the motion. In accordance with the Rules of Procedure, the motion and the amendment would be debated together in a joint debate.

Hon LEE Cheuk-yan moved the following amendment to the Secretary for Education and Manpower's motion and addressed the Council:

Resolved that the motion to be moved by the Secretary for Education and Manpower under section 40 of the Pneumoconiosis (Compensation) Ordinance (Cap. 360) at the Legislative Council meeting of 20 December 2000 be amended by deleting "\$35,000" and substituting "\$50,000".

At 5:50 pm, the President's Deputy took the chair during the temporary absence of the President.

Question on Hon LEE Cheuk-yan's amendment to the Secretary for Education and Manpower's motion proposed.

12 Members spoke on the motion and the amendment.

At 7:00 pm, the President resumed the chair.

Another two Members spoke on the motion and the amendment.

The Secretary for Education and Manpower spoke on the amendment.

Question on Hon LEE Cheuk-yan's amendment to the Secretary for Education and Manpower's motion put.

Hon LEE Cheuk-yan claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, five were in favour of the amendment, 21 against it and one abstained; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 25 were present, 14 were in favour of the amendment

and 10 against it. (Voting record in Appendix I.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

The Secretary for Education and Manpower replied.

Question on the Secretary for Education and Manpower's motion put and agreed to.

Government motion

The Secretary for Security moved the following motion and addressed the Council:

That this Council considers that the Public Order Ordinance's existing provisions relating to the regulation of public meetings and public processions reflect a proper balance between protecting the individual's right to freedom of expression and right of peaceful assembly, and the broader interests of the community at large, and that there is a need to preserve these provisions.

Question on the Secretary for Security's motion proposed.

The Secretary for Justice spoke on the motion.

The President stated that Hon James TO and Hon Emily LAU would move amendments to the motion. In accordance with the Rules of Procedure, the motion and the two amendments would be debated together in a joint debate.

Hon James TO requested the President to suspend the meeting for 15 to 20 minutes whereas Hon Emily LAU requested the President to suspend the meeting until 9:00 am the following day, in order to allow Members to consider the speeches made by the Secretary for Security and the Secretary for Justice.

The President stated that in order to enable Members to participate fully in the debate, including those Members who had scheduled to leave Hong Kong in the afternoon of the following day, she was aiming at concluding the debate by noon the following day. Therefore she would suspend the meeting at a suitable time after 10:00 pm. She then invited Hon James TO to speak on the motion and the amendments.

Hon James TO and Hon Emily LAU spoke respectively on the motion and their amendments.

Two Members spoke on the motion and the amendments.

At 9:30 pm, the President's Deputy took the chair during the temporary absence of the President.

Another two Members spoke on the motion and the amendments.

At 9:45 pm, the President resumed the chair.

Seven other Members spoke on the motion and the amendments.

At 10:50 pm, the President said that in view of the fact that a large number of Members were still awaiting their turn to speak, she would call a few more Members to speak before she suspended the meeting.

Five other Members spoke on the motion and the amendments.

The President suspended the meeting at 11:43 pm.

At 12:07 pm, the President's Deputy took the chair during the temporary absence of the President.

The Secretary for Security spoke on the amendments.

At 12:14 pm, the President resumed the chair.

With the permission of the President, two other Members spoke on the motion and the amendments.

Hon James TO moved the following amendment to the Secretary for Security's motion:

"this Council notes that, in its concluding observations issued after considering the report on Hong Kong's human rights situation submitted by the Hong Kong Special Administrative Region ("HKSAR") Government in 1999, the United Nations Human Rights Committee stated that the HKSAR Government should review the Public Order Ordinance and bring its provisions into compliance with the relevant international covenant on human rights;" after "That"; to add "also" after "this Council"; to delete "reflect a proper balance" and substitute with ", in balancing"; and to delete "and that there is a need to preserve these provisions" and substitute with "need to provide for a notification system, but the specific requirements and penalty provisions need to be amended, such as by increasing the maximum number participants to be exempt from the notice requirement, shortening the required notice period and lowering the level of penalty for non-compliance with the notice requirement, so

as to bring such provisions into line with the relevant covenant and the aspirations of a modern, democratic and liberal society".

Question on Hon James TO's amendment to the Secretary for Security's motion proposed and put.

Hon James TO claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 30 were present, seven were in favour of the amendment and 23 against it; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 28 were present, 15 were in favour of the amendment and 12 against it. (Voting record in Appendix II.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon Mrs Selina CHOW rose to move the following motion without notice:

That in the event of further divisions being claimed in respect of the remaining motions to be moved on Government motion at this meeting, Rule 47(1)(c) of the Rules of Procedure be suspended so that the President may order that the Council do proceed to each of such divisions immediately after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Hon Emily LAU moved the following amendment to The Secretary for Security's motion:

To delete "this Council considers that" and substitute with ", in view of the diversity of views in the community on"; to delete "existing"; and to delete "reflect a proper balance between protecting the individual's right to freedom of expression and right of peaceful assembly, and the broader interests of the community at large, and that there is a need to preserve these provisions" and substitute with ", this Council urges the authorities to refer this issue to the Law Reform Commission for consideration".

Question on Hon Emily LAU's amendment to the Secretary for Security's motion proposed and put.

Hon Emily LAU claimed a division. The President then ordered the Council to divide under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 30 were present, six were in favour of the amendment and 24 against it; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 28 were present, 15 were in favour of the amendment and 12 against it. (Voting record in Appendix III.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

The Secretary for Security replied.

Question on the Secretary for Security's motion put.

Hon CHAN Kam-lam claimed a division. The President then ordered the Council to divide under Rule 49(5) of the Rules of Procedure.

The President announced that 58 Members were present, 36 were in favour of the motion and 21 against it. (Voting record in Appendix IV.) Since the question was agreed by a majority of the Members present, she declared that the motion was carried.
