You will recall that during the ESC meeting held on 15 November 2000, where the Administration's proposal for the creation of a supernumerary Administrator post at Administrative Officer Staff Grade B rank in the Official Receiver's Office for a period of 2 years was discussed, you sought information on the number of insolvency cases handled by the Official Receiver's Office in the last three years. The relevant figures are set out below, divided into Bankruptcies and Company Liquidations -
