Visits to Beijing and London

On behalf of the House Committee, I write to invite you to attend a meeting of the Legislative Council to brief Members on your visits to Beijing and London, and to answer their questions.

Perhaps your visit to London could not have been made at a more opportune time in view of some of the comments made in the Report to the European Parliament on the First and Second Annual Reports by the European Commission on the Special Administrative Region of Hong Kong. We would like to know more about your various meetings with the British Prime Minister, other senior members of the British Government and business leaders.
