Paper for the House Committee Meeting of the Legislative Council on 17 November 2000

Legal Service Division Report on Resolution under section 134(1) of the Magistrates Ordinance (Cap. 227)

The Secretary for the Treasury ("the Secretary") has given notice to move a motion at the meeting of the Legislative Council on 29 November 2000 under section 134 of the Magistrates Ordinance (Cap. 227), which empowers the Chief Justice to make regulations with the approval of the Council.

2. Regulation 2 of the Magistrates (Fees) Regulations (Cap. 227 sub. leg.) ("the Regulations") provides for scale of fees to be taken at the magistrates' courts. The motion seeks to revise various fees payable under the Regulations. Upon approval by the Council, the fees increase will come into operation on 12 January 2001. The items to which the fees relate, the existing fees and the proposed fees are set out below—

- 3. According to the Secretary's draft speech, which is appended to the motion, the fees increase is on full-cost recovery basis. These fees were last revised in 1994. It further says that the Panel on Financial Affairs of the last legislative session was consulted, at its meeting on 15 June 2000, about proposals to revise various fees and charges not affecting people's livelihood or general business activities under the Secretary's purview, including the fees under the Magistrates Ordinance. The Panel in general raised no objection.
- 4. The legal and drafting aspects of the resolution are in order.
