Part I Specification of Public Office

Interpretation and General Clauses Ordinance (Cap. 1) Specification of Public Office (L.N. 93)

By this Notice, the Chief Secretary for Administration may delegate to other public officers his power under section 9(3) of the Scout Association of Hong Kong Ordinance (Cap. 1005) ("the Ordinance"). Section 9(2) of the Ordinance requires certain officers of the Scout Association of Hong Kong to furnish to the Chief Executive evidence of their appointment. Section 9(3) of the Ordinance provides that a notification in the Gazette under the hand of the Chief Secretary for Administration that such evidence has been furnished to the Chief Executive by the officer shall be conclusive evidence of such appointment.

Protection of Children and Juveniles Ordinance (Cap. 213)

This Order adds Wing Lung Bank Golden Jubilee Sheltered Workshop and Hostel to the list of places of refuge specified for the purposes of the Protection of Children and Juveniles Ordinance (Cap. 213).

This Order appoints the Mau Tau Wai Girls' Home as a place of detention for the purposes of the Juvenile Offenders Ordinance (Cap. 226).

Remand Home (Amendment) Rules 2001 (L.N. 96)

These Rules add the Mau Tau Wai Girls' Home to the Schedule to the Remand Home Rules (Cap. 226 sub. leg.) so as to make those Rules apply to the remand section of that Girls' Home.
