SUBCOMMITTEE TO FOLLOW UP THE OUTSTANDING CAPITAL WORKS PROJECTS OF THE FORMER MUNICIPAL COUNCILS

Matters arising from meeting held on 3 May 2001

INTRODUCTION

At a meeting of the said Subcommittee held on 3 May 2001, Members requested the Administration to provide -

- (a) a list of ex-Provisional Municipal Council (PMC) projects for which funding has been sought and approved after the dissolution of the PMCs; and
- (b) the five-year programmes of capital works projects involving municipal services/facilities before and after dissolution of the two PMCs, and the average annual provision(s) for such facilities.

THE ADMINISTRATION'S RESPONSE

Projects funded

- 2. In late 1999, the Finance Committee of the Legislative Council approved an allocation of \$5.4 billion to fund 149 capital works projects and over 3 000 minor items for which the two PMCs had entered into contractual commitment. Government also undertook to earmark funding, in the order of \$2.4 billion, to deal with the 12 other projects which had secured PMC's funding approval even though there were no contractual commitments associated with these projects at the time. Details on these projects were set out in PWSC(1999-2000)76 and FCRI(1999-2000)17.
- 3. In the context of the 2000 capital works resource allocation exercise, the Secretary for Home Affairs and Secretary for Environment and Food secured a further allocation of some \$1 billion for nine other projects, as listed in the Annex. None of their bids on former PMC projects was rejected.

Five-year programme

- 4. The Administration will develop a rolling five-year programme for the provision of leisure and cultural facilities. Pending completion of this exercise hopefully around late 2001, we are not yet in a position to assess in a comprehensive manner how the capital works programmes on the above services compare before and after the dissolution of the PMCs. The following, however, provides a snapshot at the moment.
- 5. Records indicate that for the five years before the dissolution of the ex-PMCs (1995-97 triennium to 31 December 1999), the two PMCs approved on average a funding commitment of some \$2.4 billion per annum on related capital projects. The average expenditure on these projects was \$1.9 billion per annum.
- 6. In the past one and half year that has lapsed since the dissolution of the PMCs, we have already set aside some \$8.8 billion for ex-PMC projects, averaging a commitment of \$5.9 billion per annum in total or \$2.3 billion per annum if the former contractual commitments are excluded. For the five-year period ending 31 March 2005, we expect to spend about \$6.2 billion on the projects which have secured funding; this implies an average spending of some \$1.2 billion per annum.
- 7. The Administration will continue to vet and process as appropriate all the outstanding capital works projects initiated by the PMCs. We will also initiate new projects provided sufficient justification exists.
