SUBCOMMITTEE TO FOLLOW UP THE OUTSTANDING CAPITAL WORKS PROJECTS OF THE FORMER MUNICIPAL COUNCILS

Outcome of Consultation with District Councils on the Remaining Outstanding Projects not Included in the Accelerated Programme

PURPOSE

This paper reports on the outcome of the consultation with District Councils (DC) and the proposed way forward for the remaining 75 ex-Provisional Municipal Councils (ex-PMC) projects not included in the Accelerated Programme (AP).

BACKGROUND

2. A consultation exercise to report to DCs on LCSD's five-year work plan outlined in the AP and to seek their views on the remaining 75 ex-PMC projects was concluded in mid May.

OUTCOME OF THE CONSULTATION

3. Most DCs showed appreciation to the Administration of the definitive time-frame for implementing the 64 AP projects. However, some DCs requested that certain AP projects should be further advanced. LCSD will follow up and seek to further advance project implementation as far as practicable.

- 4. Of the remaining 75 ex-PMC projects, LCSD made the following recommendations:
 - (a) eight projects can be implemented as minor works items. DCs had no objection in principle to LCSD's recommendation for eight projects to be carried out as minor works items. A list of these projects, together with LCSD's assessment and DCs' views, is at *Annex 1*;
 - (b) eight projects can be deleted. DCs indicated no objection to LCSD's recommendation for eight projects to be deleted. A list of these projects, together with LCSD's assessment and DCs' views, is at *Annex 2*;
 - (c) for the remaining 59 projects, the relevant DCs had strongly requested that the following nine projects be given priority for implementation
 - 276LS Ecological Park (Tso Kung Tam Valley Tsuen Wan)
 - 120CR Lam Tin North Family Leisure Centre
 - 126CR Leisure Centre at Wah Fu
 - 227LS Indoor Recreation Centre Area 9H Kwai Chung
 - 006CE Civic Centre for Islands District
 - 007CE Civic Centre for North District
 - 009CE Tai Po New Civic Centre and Library
 - 306LS Indoor Recreation Centre in Area 4, Sai Kung
 - 116CR Ngau Chi Wan Recreation Ground (Landfill site)

In addition to the above nine ex-PMC projects, the Kwun Tong DC and the Tai Po DC had respectively requested LCSD to accord

priority to three non ex-PMC projects, including the provision of a civic centre in Kwun Tong, the development of an artificial beach at Lung Mei and the extension of the Tai Po Public Swimming Pool. A summary of DCs' views and LCSD's assessment on the nine ex-PMC projects and three new projects is at *Annex 3*.

- (d) regarding the remaining 50 ex-PMC projects, LCSD recommended and DCs generally agreed that these projects should be reviewed at a later stage for the following reasons
 - Implementation of certain projects such as the New Tennis Centre cum Carpark at Moreton Terrace will be subject to the outcome of the "Consultancy Study on Requirements for Major New Sports and Recreation Venues".
 - The sites for some projects are not yet formed or not suitable for development for the time being. Some projects would involve land resumption and massive clearances.
 - The need for some projects is not pressing either because of existing facilities being able to meet the demand of residents or limited demand.

A list of these projects, together with LCSD's assessment and DCs' views, is at *Annex 4*.

5. The breakdown of the 160 ex-PMC projects at *Annex 5* shows the outcome of the first review in 2001, resulting in the establishment of the AP, and the second review cum DC consultation exercise in 2002.

THE PROPOSED WAY FORWARD

6. We will proceed to implement para 4(a) and (b). For the 12 projects which the DCs had requested early implementation (para 4(c) above), subject to budgetary constraints, we will carefully consider them in the context of the established procedures for PWP projects.

7. For the remaining 50 projects (para 4(d) above), we would review in consultation with respective DCs on a continuous basis to identify justified projects where there are changes in circumstances which render them suitable for development.
