The Subcommittee deliberated (Index of proceedings attached at **Annex**).

- 2. Members other than Mr Tommy CHEUNG agreed that no amendment should be made to sections 3(1), 5(1), 6, 11(1) and (2), 12(1) and (2), 17(4) and (5) of the Regulation. Mr Tommy CHEUNG tabled his proposed amendments to those sections and consequential amendments to sections 3(2), 11(3) and (4), 17(6), (7) and (8) of the Regulation.
- 3. Mr Tommy CHEUNG's proposal to repeal section 21 of the Regulation was discussed at the meeting, but no consensus was reached. As suggested by Mr TAM Yiu-chung, the Administration undertook to consider the proposal and give a written reply on 22 October 2001. If the Administration did not accept the proposal, members' views would be sought by circulation on whether section 21 should be repealed. If a majority of members supported the proposal, an amendment to repeal section 21 of the Regulation would be moved by the Chairman on behalf of the Subcommittee; otherwise Mr Tommy CHEUNG would move the amendment in his name.
- 4. The Administration would move amendments to the following provisions -

(a) Schedule 4 of the Regulation

to revise the tattoo mark requirement for pig under paragraph (a) from "comprising 5 separate alphanumeric characters" to "comprising at least 5 separate alphanumeric characters" to allow more flexibility and cater for future change; and

(b) Section 4 of the Amendment Regulation

to add "import" in Regulation 3A of Cap. 132 sub. leg. to prohibit both the import and sale of fish, meat and milk containing prohibited substances.

5. There being no other business, the meeting ended at 10:40 am.
