I Election of Chairman and Deputy Chairman

Ir Dr HO Chung-tai, the member who had the highest precedence in the Council amongst those who had joined the Panel, presided over the election of the Chairman of the Panel for the 2000-2001 session. <u>Ir Dr HO</u> invited nominations for the chairmanship of the Panel, in accordance with the election procedures set out in Appendix IV of the House Rules.

- 2. Dr TANG Siu-tong was nominated by Mr IP Kwok-him and seconded by Mr LAU Wong-fat. Dr TANG accepted the nomination. Mr Albert CHAN Wai-yip, who was not present at the meeting, was nominated by Mr James TO Kun-sun. Mr TO indicated that he had secured Mr CHAN's acceptance of the nomination. The nomination was seconded by Mr Abraham SHEK Lai-him.
- 3. As there were two nominations, <u>Ir Dr HO Chung-tai</u> announced that the nominations be put to a vote by secret ballot. After voting, <u>Ir Dr HO Chung-tai</u> declared that there were five votes for Dr TANG Siu-tong and two votes for Mr Albert CHAN Wai-yip. <u>Dr TANG Siu-tong</u> was declared elected as Chairman of the Panel for the 2000-2001 session.
- 4. <u>Dr TANG Siu-tong</u> took over the chair of the meeting and invited nominations for the deputy chairmanship. Mr LAU Ping-cheung was nominated by <u>Mr Abraham SHEK Lai-him</u> and seconded by <u>Ir Dr HO Chung-tai</u>. There being no other nominations, <u>Mr LAU Ping-cheung</u> was declared Deputy Chairman of the Panel for the 2000-2001 session.

II Schedule of meetings for the 2000-2001 session

- 5. <u>Members</u> agreed that regular meetings of the Panel would be held on the first Monday of each month at 8:30 am.
- 6. <u>Members</u> noted that a Panel meeting had been scheduled on Wednesday, 18 October 2000, at 10:15 am to receive briefings by the Secretary for Works and the Secretary for Planning and Lands on the Chief Executive's Policy Address 2000.

III Discussion items for the next meeting

- 7. <u>Members</u> agreed that the first regular meeting of the Panel would be held on Monday, 6 November 2000, at 8:30 am to discuss the following -
 - Progress of work following the enactment of the Urban Renewal Authority Ordinance;

- Western District Development; and
- Upgrading of the Chief Assistant Secretary (Professional Services) post from Chief Engineer (D1) to Government Engineer (D2) for the promotion of the construction services industry of Hong Kong in the Mainland of China.
- 8. <u>Members</u> also agreed that the Administration should be requested to provide a written response on the progress of the Town Planning Bill before deciding how to proceed with the matter.
