## Meeting of LegCo Panel on Security on 18 January 2001 Crime Statistics in 2000

At the meeting of the LegCo Panel on Security held on 18 January 2001, during the discussion on the subject of "Crime Statistics in 2000", Members requested the Administration to provide the following additional information –

- (a) number of cases in respect of drug seizures;
- (b) number of cases where victims lost control due to the effect of drugs; and
- (c) number of occasions on which prosecutions were instituted under the Organised and Serious Crimes Ordinance (OSCO).

The requested information are provided below for Members' information.

### Number of cases in respect of drug seizures

A total of 9,583 cases of drug seizures were made in 2000. This represents an increase of 22.8% when compared with the 7,806 cases of seizures made in 1999. A breakdown of the quantities of the most common types of drugs seized in 1999 and 2000 is as listed below –

# Number of occasions on which prosecutions were instituted under OSCO

Following the enactment of the Organised and Serious Crimes Ordinance (OSCO) in 1994, the Police powers to combat and investigate organised and serious crimes such as money laundering, power to confiscate and enhance sentencing have been strengthened. The table below provides a breakdown of the frequency of use of the powers provided under OSCO and the prosecutions instituted in 1999 and 2000 –
