INTRODUCTION

Section 29A of the Interpretation and General Clauses Ordinance (Cap.1) empowers the Financial Secretary to vary fees which have previously been fixed by subsidiary legislation made by the Chief Executive in Council. By virtue of section 3 of Cap. 1, the Financial Secretary also means the Secretary for the Treasury. In exercise of this power, the Secretary for the Treasury has made the Plant (Importation and Pest Control) (Fees) (Amendment) Regulation 2001, the Pounds Fees (Amendment) Regulation 2001 and the Dairies (Amendment) Regulation 2001 at Annexes A, B and C respectively to revise a number of fees payable under the following Regulations:-

Annexes A, B, C

(a) the Plant (Importation and Pest Control) (Fees) Regulations (Cap. 207 sub. leg.) made pursuant to the Plant (Importation and Pest Control) Ordinance(Cap. 207);

- (b) the Pounds Fees Regulations (Cap. 168 sub. leg.) made pursuant to the Pounds Ordinance (Cap. 168); and
- (c) the Dairies Regulations (Cap. 139 sub. leg.) made pursuant to the Public Health (Animals and Birds) Ordinance (Cap. 139).
- 2. Section 28(2) of the Veterinary Surgeons Registration Ordinance (Cap. 529) empowers the Financial Secretary (which also means the Secretary for the Treasury under section 3 of Cap. 1) to provide by regulation for the fees in connection with matters within the scope of the said Ordinance. In exercise of this power, the Secretary for the Treasury has made the Veterinary Surgeons Registration (Fees) (Amendment) Regulation 2001 at Annex D to revise the fees payable under the Veterinary Surgeons Registration (Fees) Regulation (Cap. 529 sub. leg.) made pursuant to the said Ordinance.
- 3. In exercise of the power under section 35 of the Rabies Regulation (Cap. 421 sub. leg.) made pursuant to the Rabies Ordinance (Cap. 421), the Director of Agriculture, Fisheries and Conservation has made the Rabies Regulation (Amendment of Schedule 1) Notice 2001 at Annex E to revise the fees payable under the Rabies Regulation.
 - 4. In exercise of the power under section 19(2) of the Dangerous Dogs Regulation (Cap. 167 sub. leg.) made pursuant to the Dogs and Cats Ordinance (Cap. 167), the Secretary for the Environment and Food has made the Dangerous Dogs Regulation (Amendment of Schedule 3) Notice 2001 at Annex F to revise the fee payable under the Dangerous Dogs Regulation.

BACKGROUND AND ARGUMENT

5. It is Government policy that certain fees and charges should in general be set out at levels sufficient to recover the full costs of providing the Most Government fees and charges have been frozen since February 1998 as an exceptional measure to ease the burden on the community at a time of economic setback. In view of the current state of economic recovery, the Administration consulted the previous LegCo Panel on Financial Affairs on 13 April 2000 on proposals to revise various fees that would not directly affect people's livelihood or general business activities. account the diverse nature of the fees involved, Members suggested and the previous LegCo House Committee agreed on 14 April 2000 that the Administration should consult the relevant LegCo Panels on whether, and if so, how the fees under their respective purview should be adjusted. connection, the Administration consulted the previous LegCo Panel on the Health Services on 16 June 2000 and submitted a further information paper on 9 November 2000 on our proposals to revise the fees for the services related to

the control of animals and plants and the registration of veterinary surgeons provided by the Agriculture, Fisheries and Conservation Department (AFCD).

- Among the proposed fees, the fees under the Rabies Regulation were last revised in June 1997 and those under the Plant (Importation and Pest Control) (Fees) Regulations, the Pounds Fees Regulations and the Dairies Regulations were last revised in December 1997. The fees under the Veterinary Surgeons Registration (Fees) Regulation and the Dangerous Dogs Regulation were first introduced in November 1998 and June 2000 respectively, and the latter fee is pegged to a similar fee under the Rabies Regulation.
- 7. A costing exercise conducted at 2000-01 prices reveals that some of the fees fall short of full cost recovery. It is acknowledged that it would cause some difficulties if the fees are increased rapidly to achieve full cost recovery. The Administration therefore proposes to phase in their full cost recovery, taking account of different circumstances, along the following lines:-
 - (a) to achieve full cost recovery within three to seven years for those fees with existing cost recovery rate of 40% 70% through a 15% increase; and
 - (b) to achieve full cost recovery within one to three years for those fees with existing cost recovery rate of over 70% through a 10% or lower increase.

In short, these fees will be increased by 2.9% to 15% in the current fee revision exercise.

- 8. The costing result also reveals that some of the existing fees exceed the full costs which have been reduced as a result of streamlining of operations. The Administration therefore proposes to reduce such fees by 10% to 42% to tally with the full costs at 2000-01 prices.
- 9. Regarding the subsidized fees related to the quarantine maintenance of plants, the treatment of plants and soil, the impounding and detention of animals, the Administration proposes to increase them by 2.9% to maintain their real values, based on the movement of the Government Consumption Expenditure Deflator from 1997-98 to 2000-01.

THE REGULATIONS

11. The proposed legislation at Annexes A to F seeks to revise the fees payable under the respective Regulations as set out at Annexes M to R. The Administration proposes that the new fees should take effect from 16 February 2001.

PUBLIC CONSULTATION

12. The Administration consulted the previous LegCo Panel on Health Services on 16 June 2000 and submitted a further information paper on 9 November 2000 on the above fee revision proposals. Members of the Panel did not raise any objection. The trades concerned were also consulted on the proposals and generally raised no objection.

BASIC LAW IMPLICATIONS

13. The Department of Justice advises that the proposed legislation is consistent with the Basic Law.

HUMAN RIGHTS IMPLICATIONS

14. The Department of Justice advises that the proposed legislation has no human rights implications.

BINDING EFFECT OF THE LEGISLATION

15. The proposed legislation will not affect the binding effect of the related Regulations.

FINANCIAL AND STAFFING IMPLICATIONS

16. The above proposals are estimated to bring in an additional revenue of \$220,000 per annum. There are no staffing implications.

ECONOMIC IMPLICATIONS

17. The proposed fee revisions should have no significant economic impacts.

EFFICIENCY INITIATIVES

18. AFCD is committed to providing an efficient service to the public. Through the implementation of efficiency initiatives including streamlining of

procedures, it is able to propose fee reductions in some of the services included in the current fee revision exercise and to increase outputs without additional staff. In 1999, AFCD handled 1,370 import inspections on plants and issued 2,598 import licences, representing increases of 39% and 19% over the outputs in 1998 respectively.

PUBLICITY

19. The proposed legislation will be gazetted on 5 January 2001. A press release announcing the fee revisions will be issued on the same day.
