

## **LEGISLATIVE COUNCIL BRIEF**

### **Road Traffic (Traffic Control) (Amendment) Regulation 2001**

#### **INTRODUCTION**

By virtue of section 11 of the Road Traffic Ordinance (Cap. 374) and subsection 28(1)(c) of the Interpretation and General Clauses Ordinance (Cap. 1), the Secretary for Transport is empowered to make and amend the Road Traffic (Traffic Control) Regulations (Cap. 374, sub. leg. G).

2. In exercise of this power, the Secretary for Transport has made the Road Traffic (Traffic Control) (Amendment) Regulation 2001 at **Annex A**.

#### **BACKGROUND AND ARGUMENT**

3. Review of the design standards and applications of traffic signs and road markings is an on-going process. During a recent review of traffic signs and road markings, the Government has identified a number of existing traffic signs that require revisions to facilitate traffic management or improvements by simplifying their designs and enhancing their readability to assist the motoring public.

4. Schedule 1 to Cap. 374, sub. leg. G contains figures of regulatory, warning and informatory signs, and supplementary plates prescribed in those Regulations. Beneath each sign/supplementary plate is a note explaining its meaning. It is also stipulated in the note of each sign, where applicable, combination of plate(s) which may be used in conjunction with that particular sign. Similarly, in the note of the relevant supplementary plate there is a corresponding description of the compatible main sign.

5. We propose to amend Schedule 1 by adding the revised designs of “No-stopping Restriction Zone” and “Bus Only Lane” signs and their variations. These are existing regulatory traffic signs, which have been identified for improvement by redesigning their sign faces for better readability and aesthetic appearance.

6. We also propose to amend some main traffic signs and supplementary plates, and amend the notes to these signs and supplementary plates, so as to allow the necessary sign/supplementary plate combinations for traffic management purposes.

7. “Taxi” is a class of vehicle stipulated in the Road Traffic Ordinance (Cap 374). However, the terms of “Urban taxi”, “N T taxi” and “Lantau taxi” are not defined in the Road Traffic Ordinance or Cap. 374, sub. leg. G. The opportunity is taken in this legislative amendment to define clearly the three kinds of taxi under “Regulation 2 - Interpretation” of Cap. 374, sub. leg. G to facilitate flexibility in implementing traffic control measures to a particular kind of taxi.

## **AMENDMENT REGULATION**

8. The Amendment Regulation is to:

- (a) add the definitions of “Lantau taxi”, “N T taxi” and “Urban taxi”;
- (b) specify the signs or plates that could be used in conjunction with other signs and plates in Schedule 1; and
- (c) specify further traffic signs in Schedule 1.

## **PUBLIC CONSULTATION**

9. The proposed amendments were presented to the Transport Advisory Committee and circulated to the Legislative Council Panel on Transport on 19 September and 24 November 2000 respectively. There were no objections to the proposals.

## **HUMAN RIGHTS IMPLICATIONS**

10. The Department of Justice advises that the Amendment Regulation has no human rights implications.

## **BASIC LAW IMPLICATIONS**

11. The Department of Justice advises that the Amendment Regulation is consistent with the Basic Law.

## **FINANCIAL AND STAFFING IMPLICATIONS**

12. There are no financial and staffing implications.

## **ECONOMIC IMPLICATIONS**

13. There are no economic implications.

## **LEGISLATIVE TIME TABLE**

14. The Amendment Regulation will come into effect on 1 July 2001.

## **PUBLICITY**

15. The Amendment Regulation will be gazetted on 27 April 2001.

**ROAD TRAFFIC (TRAFFIC CONTROL) (AMENDMENT)  
REGULATION 2001**

(Made under section 11 of the Road Traffic  
Ordinance (Cap. 374))

**1. Commencement**

This Regulation shall come into operation on 1 July 2001.

**2. Interpretation**

Regulation 2(1) of the Road Traffic (Traffic Control) Regulations (Cap. 374 sub. leg.) is amended by adding -

"'Lantau taxi" (大嶼山的士) means a taxi that is licensed to be available for hire or to carry passengers within the permitted area as specified in paragraph 2 of Schedule 7 to the Road Traffic (Registration and Licensing of Vehicles) Regulations (Cap. 374 sub. leg.);

"'N T taxi" (新界的士) means a taxi that is licensed to be available for hire or to carry passengers within the permitted area as specified in paragraph 1 of Schedule 7 to the Road Traffic (Registration and Licensing of Vehicles) Regulations (Cap. 374 sub. leg.);

"'Urban taxi" (市區的士) means a taxi but does not include a Lantau taxi or an N T taxi;"

### **3. Bus lane**

Regulation 12(4) is amended, in the definition of "permitted user", by repealing "or 119" and substituting ", 119 or 164".

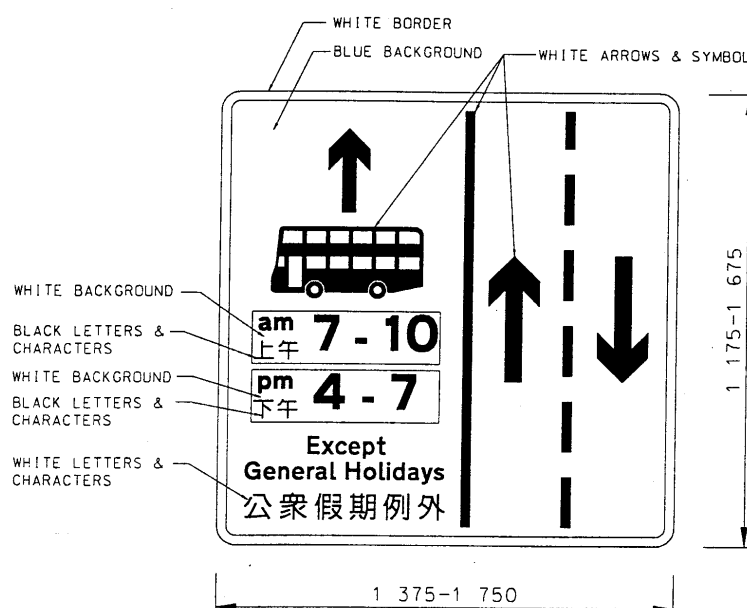
### **4. Traffic signs**

Schedule 1 is amended -

- (a) in Figure No. 106, in the note, by repealing "402, 403" and substituting "401, 402, 403, 427, 431, 432";
- (b) in Figure No. 107, in the note, by repealing "402, 403, 409" and substituting "401, 402, 403, 409, 427, 431, 432";
- (c) in Figure No. 109, in the note, by repealing "402, 403, 409" and substituting "401, 402, 403, 409, 427, 431, 432";
- (d) in Figure No. 113, in the note, by repealing "429" and substituting "427, 429, 431, 432";
- (e) in Figure No. 122, in the note, by repealing "403, 406" and substituting "401, 403, 406, 427, 431, 432";
- (f) by adding -

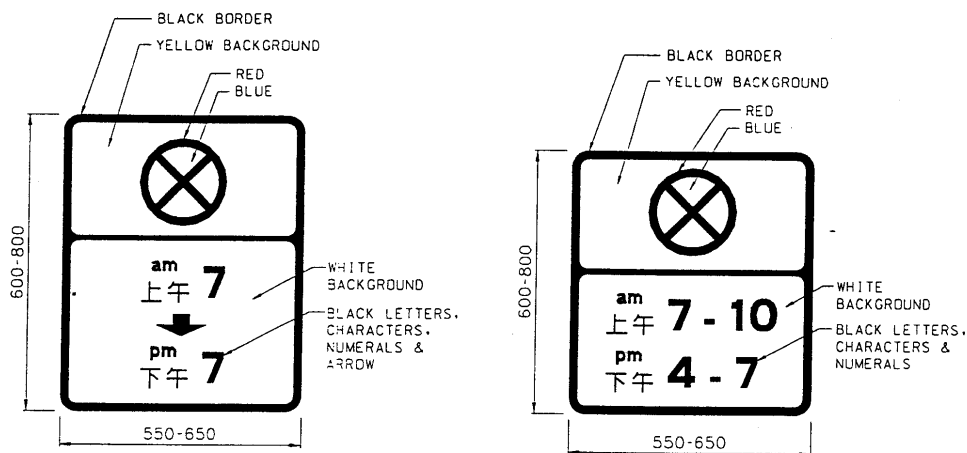
THE NUMBER AND DIRECTION OF ARROWS MAY BE ALTERED TO SUIT THE NUMBER OF LANES AVAILABLE.

THE SIGN MAY BE VARIED TO INDICATE THAT MOTOR VEHICLES EXCEPT FRANCHISED BUSES ARE PROHIBITED FROM USING THE CENTRE OR OFFSIDE LANE.

WHERE OTHER BUSES ARE PERMITTED TO USE THE LANE IN ADDITION TO FRANCHISED BUSES, THE SYMBOL IN THE ABOVE SIGN SHALL BE REPLACED BY "BUS 巴士".

"NO STOPPING" ZONE

THIS SIGN SHALL BE ERECTED FACING ONCOMING VEHICLES TO INDICATE THE START OF A NO STOPPING ZONE WHERE RESTRICTIONS ON STOPPING FOR ALL VEHICLES EXCEPT FRANCHISED BUSES AT DESIGNATED BUS STOPS APPLY. THE TIMES MAY BE VARIED TO SPECIFY ANY PERIODS OF TIME OR TIMES OR IN 24-HOUR TIME DISPLAY WITHOUT THE WORDS "am" AND "上午" AND/OR "pm" AND "下午".

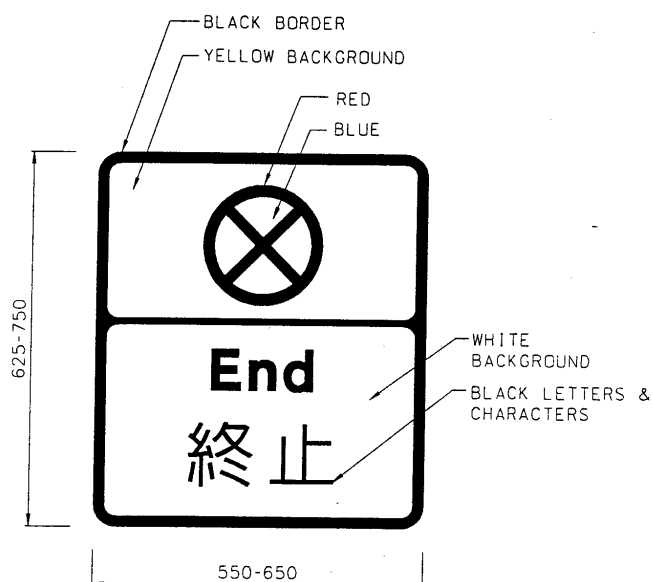
YELLOW BACKGROUND IN THE UPPER PART OF THE SIGN MAY BE VARIED TO WHITE FOR USE AT INTERVALS ALONG THE ROUTE AS REMINDERS OF THE RESTRICTIONS IN FORCE.

THE SIGN MAY BE USED IN CONJUNCTION WITH THE SUPPLEMENTARY PLATES IN FIGURE Nos. 429, 430.

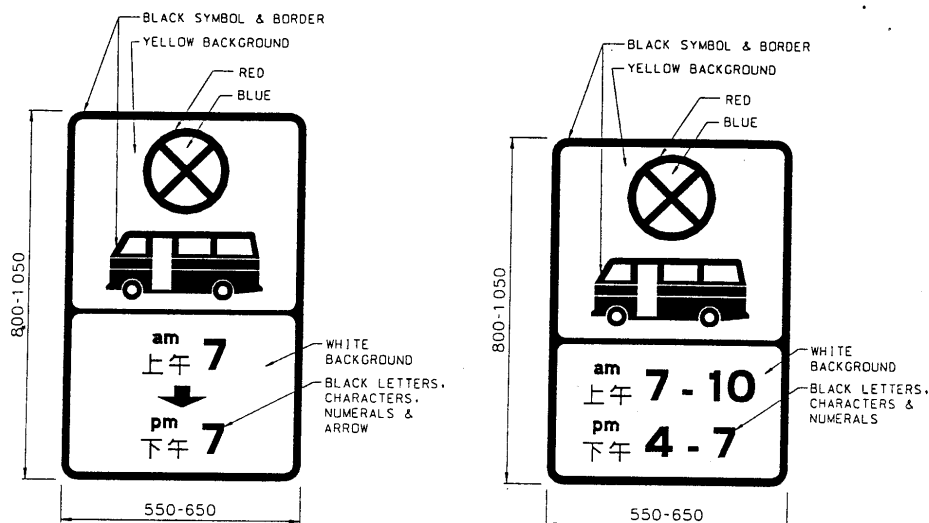


"NO STOPPING" ZONE END

THE TIMES MAY BE VARIED TO SUIT ANY PERIODS OF TIME OR TIMES OR IN 24-HOUR TIME DISPLAY WITHOUT THE WORDS "am" AND "上午" AND/OR "pm" AND "下午".

THE SIGN SHALL BE ERECTED FACING ONCOMING VEHICLES TO INDICATE THE START OF THE RESTRICTION.

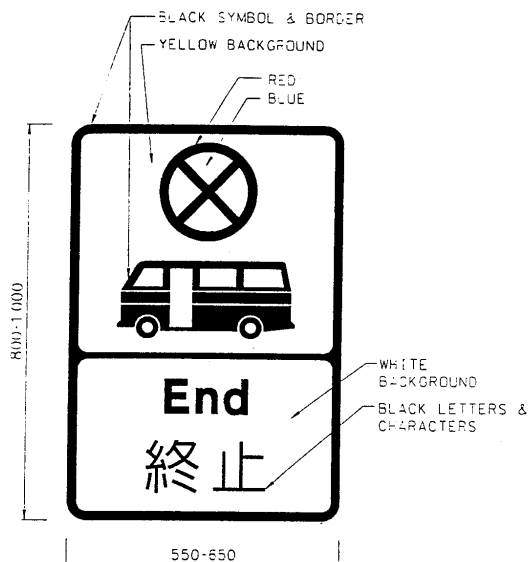

THE PUBLIC LIGHT BUS SYMBOL MAY BE VARIED TO THE BUS SYMBOL SHOWN IN FIGURE No. 115 OR THE GOODS VEHICLE SYMBOL SHOWN IN FIGURE No. 117 TO INDICATE THE START OF NO STOPPING ZONE FOR BUSES OR GOODS VEHICLES RESPECTIVELY.

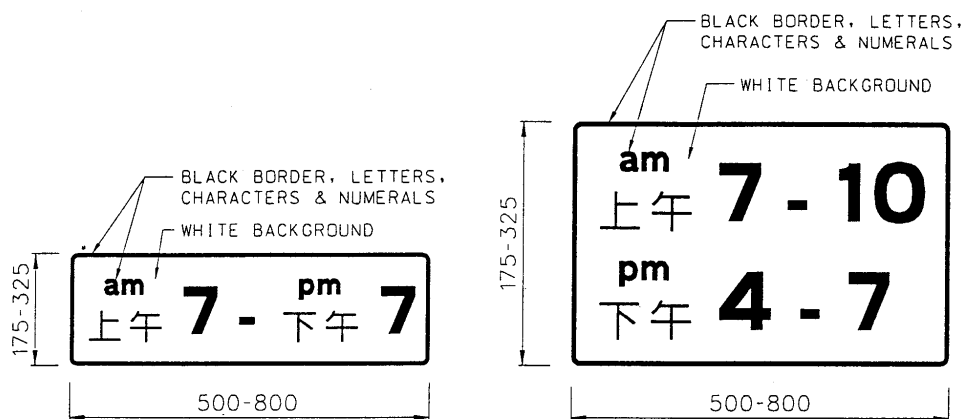

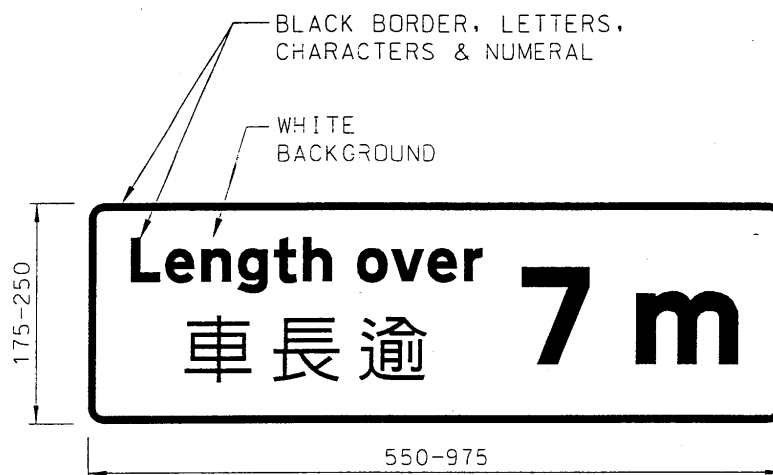
THIS PLATE IS A VARIATION IN SIZE AND FORMAT OF FIGURE NO. 406.

THE WORDING MAY BE VARIED TO SPECIFY ANY PERIOD OF TIME OR TIMES OR IN 24-HOUR TIME DISPLAY WITHOUT THE WORDS "am" AND "上午" AND/OR "pm" AND "下午".

**Explanatory Note**
