# 定額罰款(公眾地方潔淨罪行)規例

# 引言

本摘要解釋載於<u>附件</u>的《定額罰款(公眾地方潔淨罪行)規例》("該規例")。

# 背景

- 2. 立法會在二零零一年七月通過《定額罰款(公眾地方潔淨罪行)條例》("該條例")。該條例旨在透過訂立定額罰款制度,以期對觸犯輕微的公眾地方潔淨罪行(包括在公眾地方亂抛垃圾、吐痰、未經准許而展示招貼或海報,以及犬隻糞便弄污公眾地方) 起阻嚇作用。違例者可處定額罰款 600 元。
- 3. 新法例規定,定額罰款通知書須送交違例者,而就有關罪行進行法律程序時,須向裁判官出示證明書,以證明違例者欠繳定額罰款。該條例第 17 條賦權環境食物局局長訂立規例,以便進行多項工作,其中包括:
- (a) 根據該條例訂明通知書或證明書;
- (b) 指明定額罰款或附加罰款的收款人及繳款地點;以及
- (c) 指明定額罰款或附加罰款的付款方式。

# 規例

4. 規例訂明通知書/證明書的格式和付款方式。通知書/證明書以《定額罰款(交通違例事項)規例》(第 237 章,附屬法例)爲模式,並作出適當的修改。

# 與基本法的關係

5. 律政司認爲,擬議規例與《基本法》中不涉及人權的條文並無抵觸。

# 與人權的關係

6. 律政司認爲,擬議規例與《基本法》中有關人權的條文相符。

# 法例的約束力

7. 律政司認爲,擬議規例將不會影響《定額罰款(公眾地方潔淨罪行)條例》的現有約束力。

# 對財政和人手的影響

8. 擬議規例對人手和財政沒有影響。至於資本開支方面,現正 爲處理定額罰款通知書安裝電腦系統,費用爲 5,072,000 元。

# 立法程序時間表

9. 擬議規例將於二零零二年四月四日刊登憲報,並於二零零二年四月十日提交立法會。

## 公眾諮詢

10. 當局在二零零一年二月把《定額罰款(公眾地方潔淨罪行)條例草案》提交立法會之前,已諮詢食物及環境衞生諮詢委員會、 清潔香港策劃委員會以及立法會食物安全及環境衞生事務委員 會。該三個委員會的委員大致上支持有關建議。該條例草案隨後 於二零零一年七月十二日獲得立法會通過。

## 宣傳安排

11. 當局將會展開一系列宣傳計劃,以確保公眾充分知悉有關定額罰款制度的實施。宣傳計劃包括發表新聞公告、在電台及電視播放政府宣傳聲帶和宣傳短片、張貼海報和橫額,以及在有需要時舉辦特別宣傳活動。
