In proposed section 35A –

- (a) in subsection (2)(b), by deleting "subsection(3)" and substituting "subsections (3), (3A) and (3B)";
- (b) by deleting subsection (3) and substituting
 - "(3) A copy of a work feature film that is embodied in an article is not a copy of an associated work for the purposes of subsection (2) if the work is a film of the kind commonly known as a movie and if the copy
 - (a) the copy is a copy of the moviea feature film in its entirety or substantially in its entirety; or
 - (b) where the copy is a copy of a part of a feature filmthe movie (not being a part to which paragraph (a)

applies), and -

- (i) that part together with all other parts of the movie all those parts of the feature film copies of which are embodied in the article together constitute the feature film movie in its entirety or substantially in its entirety; or
- (ii) the duration of that part together with all other parts of the movie the viewing time of all those parts of the feature film copies of which are embodied in the article when viewed (as embodied in the article) constitute is more than 15 minutes in aggregate.
- (3A) A copy of a worktelevision drama that is embodied in an article is not a copy of an associated work for the purposes of subsection (2) if the

work is a film of the kind commonly known as a television drama and if the copy –

- (a) the copy is a copy of the a television drama in its entirety or substantially in its entirety; or
- (b) where the copy is a copy of a-part of the a television drama (not being a part to which paragraph (a) applies), and
 - (i) that part together with all other those parts of the television drama copies of which are embodied in the article together constitute the television drama in its entirety or substantially in its entirety; or
 - (ii) the duration of that part together with the viewing time of all other those parts of the television drama copies of which are embodied in the

article when viewed (as embodied in the article) constitute is more than 10 minutes in aggregate,

and in paragraphs (a) and (b)(i), reference to a television drama, in the case of a television drama comprising one or more episodes, means is a reference to an episode of the television drama.

(3B) A copy of a work musical sound recording that is embodied in an article is not a copy of an associated work for the purposes of subsection (2) if the work is a musical sound recording or a musical visual recording, and the economic value of the article is predominantly attributable to _

- (a) the economic value of the copy, or to the combined economic value of all such copies, as embodied in the article."; or—
- (b) where copies of more than 1 musical sound recording are embodied in the article, the combined economic value of all such copies, as embodied in the article.

(3C) A copy of a musical visual recording that is embodied in an article is not a copy of an associated work for the

purposes of subsection (2) if the economic value of the article is predominantly attributable to –

- (a) the economic value of the copy, as embodied in the article; or
- (b) where copies of more than 1 musical visual recording are embodied in the article, the combined economic value of all such copies, as embodied in the article.";
- (c) in subsection (4)
 - (i) by deleting in the definition of "feature film";, by deleting everything after "a film" and substituting "of the kind commonly known as a movie:";
 - (ii) in the definition of "musical visual recording", by adding "the sound-track accompanying" after "part of";deleting everything after "film" and substituting "with an accompanying sound-track, the whole or a predominant part of which sound-track consists of a musical work and any related literary work;";

(iii) by adding –

""television drama" (電視劇或電 視電影) means a film of the kind commonly known as a television drama." (iii<u>iv</u>) in the Chinese text, in the definition of "音樂聲音紀錄", by deleting the
