#### I Election of Chairman

Mr Eric LI, the Member who had the highest precedence in the Council among members of the Bills Committee present, presided at the election of Chairman.

- 2. <u>Mr SIN Chung-kai</u> nominated Ms Audrey EU for the chairmanship. <u>Ms Emily LAU</u> seconded the nomination. There being no other nomination, Ms EU was elected Chairman of the Bills Committee. She then took over the chair.
- 3. <u>The Chairman</u> invited members to consider Mr Albert HO's late application for membership to the Bills Committee. <u>Members</u> agreed to accept Mr HO's application. <u>Members</u> also noted that Mr Ambrose LAU had given notice to withdraw from the Bills Committee.

## II Way forward

- 4. The Bills Committee deliberated (Index of proceedings attached at **Annex**).
- The Bills Committee agreed that these organizations with which the Administration, Standing Committee on Company Law Reform and/or the Law Reform Commission had consulted on the proposals contained in the Bill, business schools of the eight local universities, associations of small and medium enterprises and Mr David M WEBB should be invited to give views on the Bill for consideration of the Bills Committee. A notice to invite views from the public should also be posted on the website of the Legislative Council.

6. <u>The Bills Committee</u> also agreed that the Secretariat should ask the Administration to provide copies of "The Report of the Standing Committee on Company Law Reform on the Recommendations of a Consultancy Report of the Review of the Hong Kong Companies Ordinance" for members' reference.
