### II Meeting with the Administration

Admin 4. The Administration undertook to take follow-up actions as follows:

- (a) to provide information on the duty-paid quantity, duty collected and changes in duty rate in respect of each type of liquor listed in Schedule 1 to the Dutiable Commodities Ordinance for the period from 1992 to 2001;
- (b) to provide information on the duty-paid quantity, duty collected in 2000, 2001 and 2002 in respect of beer to illustrate the possible implication of duty increase in 2001 on the consumption of beers of different price ranges;
- (c) to check if information on profit tax collected from catering, hospitality and entertainment sectors in recent years could illustrate the possible impact on revenue due to increases in liquor duty;
- (d) to provide information on retail prices on wine in the local market and comparable overseas markets; and
- (e) to provide a paper explaining the practices and legal bases for levying wine duty with particular reference to the mechanism for determining the relevant ex-factory price and prevailing market price.
