I. Meeting with the Administration

The Bills Committee deliberated (index of proceedings attached at **Annex**).

- 2. The Bills Committee requested the Administration to improve the drafting of the proposed Committee Stage amendments (CSAs) to clause 10 of the Bill to clarify the person to which the term "某人" referred.
- 3. The Administration undertook to -
 - (a) delete the proposed new section 7(2A)(b)(iii) in the latest CSAs proposed by the Administration; and
 - (b) provide members with the draft of the form referred to in regulation 4(1)(b) before 19 March 2003.
- 4. <u>Mr James TO</u> expressed reservations about the Administration's proposed CSA to appoint 12 May 2003 as the commencement date of the Bill. <u>The Administration</u> said that if, on 8 March 2003, the demonstration on the prototype of the Smart Identity Card System indicated that the System was not ready, the Administration was willing to reconsider the commencement date of the Bill.
- 5. <u>Mr James TO</u> suggested that a CSA be moved by the Bills Committee to amend the reference to "nationality" to "nationality which he claims" and deleting the reference to "marital status" and "occupation" in the proposed new section 7(2A)(b)(i) in the latest CSAs proposed by the Administration. <u>Members</u> agreed that the issue be dealt with after the completion of the examination of the CSAs proposed by the Administration.

- 6. The Bills Committee noted that the next meeting had been scheduled for Saturday, 1 March 2003 at 9:00 am to continue discussion with the Administration.
