- 2. The Bills Committee requested the Administration -
 - (a) To reconsider the need for a provision to the effect that the proposed defence in clause 4(5)(a) (which might be singled out) would not apply to a person who possessed more than three copies of the same child pornography, and if so, the number of copies to be used as a threshold and how such a provision would apply in relation to child pornography stored inside computers;
 - (b) To consider the suggestion of providing a defence of reasonable excuse for the possession of child pornography;
 - (c) To provide precedents, if any, to illustrate how the concept of possession was applied in relation to materials stored inside computers;

- (d) To consider exempting Internet service providers and courier service operators which had complied with a code of practice on materials deposited by their users from the offence of possession of child pornography;
- (e) To consider setting out the standard of proof required of the term "establish" in the defence provisions not relating to possession of child pornography, such as by revising the provisions along the line that the accused need to establish his defence on a balance of probabilities; and
- (f) To provide the draft Committee Stage amendments to the Bill.
