I. Confirmation of minutes of meeting held on 3 June 2002

The minutes of the meeting held on 3 June 2002 were confirmed.

II. Meeting with the Administration

- 2. The Bills Committee deliberated (index of proceedings attached at **Annex**).
- 3. The Bills Committee requested the Administration -
 - (a) To provide information on overseas court cases relating to the possession of child pornography for the purpose of publication and explain the practical difficulties in enforcement and human rights implications of an offence provision for such possession;
 - (b) To explain the difference between possession for the purpose of distribution and for the purpose of publication;
 - (c) To provide the draft Committee Stage amendments to clause 4(5) of the Bill;

- (d) To provide a response on providing an express mental element in offence provisions in the Bill, including the following:
 - (i) The suggestion of adding the element of "knowingly" to the offence provision on possession of child pornography;
 - (ii) Whether the offences set out in clause 3 of the Bill were strict liability offences;
 - (iii) The respective burden of proof of the prosecution and the defendant in respect of "knowledge"; and
- (e) To provide a response on the following issues raised by Assistant Legal Adviser -
 - (i) Whether clause 4(3) of the Bill should be widened to also provide that it was a defence for a person who received a pornographic article to report the matter to a law enforcement agency, as in the relevant legislation of the United States; and
 - (ii) Whether a person with an article that the Obscene Articles Tribunal had refused classification would be in breach of clause 3(1) of the Bill relating to production of child pornography even though he had destroyed the article within a reasonable time.

III. Date of next meeting

4. The Bills Committee agreed that the next meeting would be held on Tuesday, 16 July 2002 at 2:30 pm, pending confirmation of the Chairman's availability.

(*Post-meeting note*: As the Chairman had other commitments, the meeting scheduled for 16 July 2002 was subsequently cancelled.)

- 5. The Bills Committee agreed that relevant scenes of six movies would be shown by the Administration during the next meeting to demonstrate how mainstream movies were unlikely to be affected by the Bill. The Committee also agreed that it would not be necessary for the scenes to be shown at a closed session.
- 6. The meeting ended at 10:40 am.
