I. Election of Chairman

II. Way forward

- 3. <u>Members</u> agreed that the Administration should be requested to provide response to the following concerns raised by members -
 - (a) as Clause 8 of the Bill sought to empower the Commissioner to specify by notice in the Gazette the classes of persons or returns to which the electronic and telefiling lodgment scheme would apply, the scope of the proposed new services would remain unclear even at the time the Bill was passed;
 - (b) whether the Commissioner could advise at the present stage the classes of persons or returns to which the proposed lodgment scheme would apply;
 - (c) the reasons for specifying in the Bill that the notices made under subsections (5) and (6) in the new section 51AA were not subsidiary legislation; and
 - (d) whether consideration would be given to accepting more service providers, other than the Hong Kong Post, to support the use of password in filing tax returns electronically.
- 4. <u>The Chairman</u> suggested that the relevant professional bodies and the information technology industry should be invited to give views on the Bill. <u>Members</u> agreed.
- 5. <u>Members</u> also agreed that, to allow time for the Administration to provide further information and the professional bodies to make submissions, the next meeting should be held in October 2002. The Clerk would inform members of the date of the next meeting after consulting the Chairman.
- 6. There being no other business, the meeting ended at 2:20 pm.
