Paper for House Committee Meeting on 11 January 2002

Suggestion made by members of Sha Tin District Council on enhancing communication between the Legislative Council and District Councils

Purpose

This paper seeks the views of the House Committee on a suggestion made by members of the Sha Tin District Council on how communication between the Legislative Council (LegCo) and District Councils (DCs) could be enhanced.

Background

2. At the meeting held between LegCo Members and members of the Sha Tin District Council (STDC) on 29 November 2001, views were exchanged on how communication between LegCo and DCs could be enhanced. STDC members suggested, among other things, that LegCo Members should listen to the views of DC members on major policy issues. In this connection, the question of whether there should be a standing arrangement to inform DCs of the items of discussion of LegCo committees to facilitate consultation with DCs was also raised. LegCo Members attending the meeting with STDC members agreed that the matter should be referred to the House Committee for consideration. The extract from the draft minutes of the meeting on 29 November 2001 is at Appendix I for Members' reference.

Current arrangements and proposals

- 3. At present, LegCo committees mainly adopt the following approaches to seek views on major issues, policy initiatives, legislative proposals, etc.
 - a. If a subject matter concerned specific organisations or persons, the relevant committee would write to invite these organisations or persons to give their views on the subject matter; or

- b. If a subject matter concerned the public in general, the relevant committee would invite views by issuing press releases, or placing advertisements in newspapers, or announcing invitations for views on the LegCo website.
- 4. Regarding the approach referred to paragraph 3(a) above, it is the practice of LegCo committees to seek the views of organisations or persons concerned including those of DCs on major policies, issues and legislative proposals. For example, the Panel on Transport has received representations from the DCs concerned on Route 7 and Route 10. The Bills Committee studying the Fire Safety (Buildings) Bill has sought the views of the 18 DCs on the Bill. The subcommittee formed to follow up the outstanding capital works projects of the former municipal councils has also invited the views of the 18 DCs on the relative priorities of those projects within their districts. Committees should continue to seek the views of organisations and persons concerned, including those of DCs, as and when necessary.
- 5. As regards the approach discussed in paragraph 3(b) above, it is proposed that committees concerned should also write to the 18 DCs to invite them to give views, in addition to issuing press releases, or placing advertisements in newspapers, or announcing invitations for views on the LegCo website.
- 6. At present, a list of weekly activities of LegCo (sample at Appendix II) is available on the LegCo website. The agendas, discussion papers and minutes of meetings of Panels, Bills Committees, subcommittees on subsidiary legislation, etc. are also available on the LegCo website. DC members and other persons can find out what have been or will be discussed by these committees by visiting the LegCo website.
- 7. To make it even more convenient for DC members to find out the forthcoming items of discussion of LegCo committees, it is proposed that arrangement be made by the LegCo Secretariat to send the list of weekly activities of LegCo to individual DC Secretariats vide e-mail.

- F. Enhancing co-operation and liaison between the Legislative Council and District Councils
- 32. <u>A STDC member</u> raised the following specific proposals with a view to enhancing co-operation and liaison between LegCo and DCs:
 - (a) LegCo Members returned by geographical constituencies should regularly (at least once a year) attend meetings of the DCs of the relevant constituencies for the purpose of understanding livelihood issues which were of concern to local residents. In order to enhance mutual communication, LegCo Members should also listen to the views of DC Members on major policy issues such as measures to boost the economy, the legalization of soccer betting, education and welfare, public expenditures on capital projects, various matters arising out of the Building Management Ordinance (Cap. 344), etc.;
 - (b) The committees of LegCo should consider inviting DC members to join consultation groups, taking into account the expertise of individual DC members; and

- (c) LegCo Members should consider the desirability of increasing an additional seat for the District Council functional constituency so as to enhance the liaison between LegCo and DCs. Relevant LegCo Members should regularly visit the 18 DCs (at least twice per DC within their term of office) to collect DCs' views. A mechanism for collecting views and seeking consultation should be established, for example, by making use of the Internet for opinion polling and collecting suggestions, and setting out the views expressed by LegCo Members.
- 33. Regarding the suggestion on whether LegCo Members should consider the desirability of increasing an additional seat for the District Council functional constituency to enhance the liaison between LegCo and DCs, the Convenor stated that she was personally against the returning of LegCo Members through functional constituencies. She would only support the election of LegCo Members by direct election.
- 34. The Convenor said that an existing mechanism was already in place for LegCo Members and DC Members to communicate and exchange views on various subjects. One such arrangement was the regular meetings-cumluncheons held between LegCo Members and DC Members. In addition, LegCo Members returned by geographical constituencies would also try their best to attend the meetings of the DCs of the relevant constituencies. She stressed that LegCo would welcome all views from the public and interested parties. Any DCs or individual DC Members could always raise their concerns with LegCo Members.
- 35. Acknowledging the interest of individual DC Members might have on the work of various LegCo committees, <u>Mr YEUNG Yiu-chung</u> expressed support for LegCo committees to proactively solicit the views of DCs when

considering matters of wide public concern. Regarding the formation of consultation groups under LegCo committees, he opined that the matter might have to be considered against the rules and regulations of LegCo.

- 36. In response to the request raised by STDC Members, <u>LegCo Members</u> agreed that a list of existing Panels and Bills Committees of LegCo should be provided to STDC Members for information. On the use of the Internet to obtain information about LegCo businesses and to submit views to LegCo, <u>STDC Members</u> noted that information such as notices for inviting public views on specific matters posted by various LegCo committees, meeting dates, agendas, relevant papers and the minutes of meetings of LegCo committees, topical issues, etc. could be readily accessed through the LegCo website. STDC Members could also submit their views to LegCo electronically via an email sent through the "Enquiries" button on LegCo's homepage.
- 37. Regarding the existing arrangement for public consultation adopted by LegCo committees, the Clerk reported that when individual committees decided to invite public views on specific issues, a list of individuals/organizations to be consulted would be drawn up by the respective committees. For example, views from relevant DCs had been invited by the Transport Panel on a number of major transport infrastructure projects. As regards the question of whether a standing practice should be adopted to inform all DCs of forthcoming agenda items to be discussed by LegCo committees so as to facilitate consultation, LegCo Members agreed that the views of STDC Members should be referred to the House Committee for consideration.
