Legal Service Division Report on Motion under section 29 of the Pharmacy and Poisons Ordinance (Cap. 138)

The Secretary for Health and Welfare has given notice to move a motion at the Council meeting on 24 April 2002. The motion seeks the Legislative Council to approve the Pharmacy and Poisons (Amendment) Regulation 2002 and the Poisons List (Amendment) Regulation 2002 ("the Amendment Regulations"), both made by the Pharmacy and Poisons Board ("the Board") pursuant to section 29 of the Pharmacy and Poisons Ordinance (Cap. 138).

2. According to the draft speech of the Secretary for Health and Welfare, the Amendment Regulations seek to add 6 new medicines to Part I of the Poisons List, and the First and Third Schedules to the Pharmacy and Poisons Regulations. Their addition means that pharmaceutical products containing any of these 6 substances must be sold in pharmacies by or under the supervision of a registered pharmacist and in his presence, with the support of prescriptions given by a registered medical practitioner, registered dentist or registered veterinary surgeon.

3. In addition, the Board proposes to re-classify nicotine by transferring it from Part I to Part II of the Poisons List where it is intended to be used in nicotine replacement therapy and in the form of chewing gum containing not more than 2mg of Nicotine. As a consequence, products containing Nicotine would be allowed to be sold by an authorized seller of poisons or by a listed seller of poisons. According to paragraph 6 of the draft speech of the Secretary for Health and Welfare, it is intended that the proposed relaxation of control of Nicotine would make these products more accessible to smokers who intend to give up smoking.

4. The Board considers that the proposed amendments necessary in view of the potency, toxicity and potential side-effects of the medicines concerned.

5. Upon the request of the Legal Service Division, the Administration has provided some information on the relevant substances (copy attached) to assist Members' consideration.

6. The two Regulations will come into operation on the day they are published in the Gazette after being approved by the Legislative Council.

7. The two Amendment Regulations are in order from the legal point of view.
