#### PART I AMENDING SCHEDULE TO LEGISLATION

Civil Aviation (Aircraft Noise) Ordinance (Cap. 312) Civil Aviation (Aircraft Noise) Ordinance (Amendment of Schedule) Notice 2002 (L.N. 60)

This Notice amends the Schedule to the Civil Aviation (Aircraft Noise) Ordinance (Cap. 312) ("the Ordinance") to make the noise standards specified in Chapter 3 of Annex 16 to the Convention on International Civil Aviation ("the Chicago Convention") apply to both wide-bodied and narrow-bodied subsonic jet aircraft landing or taking-off in Hong Kong with effect from 1 July 2002.

- 2. Under the Ordinance, different noise standards apply to narrow-bodied and wide-bodied subsonic jet aircraft. All narrow-bodied subsonic jet aircraft landing or taking-off in Hong Kong are required to meet the noise standards specified in Chapter 3 of Annex 16 to the Chicago Convention. Wide-bodied subsonic jet aircraft, however, only need to comply with the noise standards specified in Chapter 2 of the Annex, which are less stringent than those specified in Chapter 3.
- 3. The effect of this Notice is to prohibit, with effect from 1 July 2002, wide-bodied subsonic jet aircraft which only meet the Chapter 2 noise standards from landing or taking-off in Hong Kong. The proposed prohibition will implement in Hong Kong the resolution adopted by the International Civil Aviation Organization in October 1990 to phase out Chapter 2 aircraft over a period of not less than 7 years starting from 1 April 1995.

- 4. Members may refer to LegCo Brief (Ref: ESB CR8/3231/83) dated 2 May 2002 for background information. According to the LegCo Brief, the Administration has consulted all airlines operating scheduled services to and from Hong Kong, the Airport Authority and aircraft maintenance companies on the proposed prohibition. They have not indicated any problem with the proposed prohibition. The Aviation Advisory Board was also consulted on 15 October 2001 and members supported the proposal.
- 5. The Panel on Economic Services was consulted on 28 January 2002 on Members welcomed the proposal to tighten aircraft noise control which might benefit residents living along the flight path. They however had expressed concern about the implications of the proposal on the economy and the industry. Regarding the implementation timetable, a member considered it desirable to effect the prohibition as from 1 April 2002 so as to tally with the practice of other overseas Another member however considered that it might be necessary to defer implementing the proposed prohibition beyond 1 May 2002 to allow more time to assess the impact on the industry. As requested by members, the Administration undertook to provide the Panel with information concerning the policies of Mainland China and Macau aeronautical authorities in respect of noise standards for aircraft. The Administration has now replied that the aeronautical authority in Mainland China intends to prohibit shortly the operation of wide-bodied Chapter 2 aircraft while the aeronautical authority in Macau has no intention to implement the prohibition for the time being.
- 6. The legal and drafting aspects of the Notice are in order.
