Legal Service Division Report on Motion under section 29 of the Pharmacy and Poisons Ordinance (Cap. 138)

The Secretary for Heath and Welfare (the Secretary) has given notice to move a motion at the Council meeting on 26 June 2002. The motion seeks the Legislative Council to approve the Pharmacy and Poisons (Amendment) (No. 2) Regulation 2002 and the Poisons List (Amendment) (No. 2) Regulation 2002 ("the Amendment Regulations"). The Amendment Regulations are made by the Pharmacy and Poisons Board ("the Board) pursuant to section 29 of the Pharmacy and Poisons Ordinance (Cap. 138) (the Ordinance).

- 2. According to the draft speech of the Secretary, the Amendment Regulations seek to add 3 new medicines, i.e. Caspofungin, Deferiprone and Ganirelix, to Part I of the Poisons List, and the First and Third Schedules to the Regulation. The Secretary has provided some supplementary information on those 3 new medicines which is attached herewith for Members' easy reference (see **Annex**). Their addition means that pharmaceutical products containing any of those 3 new substances must be sold in pharmacies by or under the supervision of a registered pharmacist and in his presence, with the support of prescriptions given by a registered medical practitioner, registered dentist or registered veterinary surgeon.
- 3. The Board also proposes to amend the exemption level for individual steroid compound contained per dose in the oral contraceptive products in the Second Schedule to the Pharmacy and Poisons Regulation. This will tighten the control of oral contraceptive products containing oestrogenic and progestational substances.
- 4. The two Amendment regulations will come into operation on the day they are published in the Gazette after being approved by the Legislative Council.
- 5. The two Amendment Regulations are in order from the legal point of view.
