# Paper for the House Committee meeting on 9 November 2001

#### **Parliamentary Liaison Subcommittee**

#### Proposed parliamentary visit to Canada and the United States

### **Purpose**

This paper invites the House Committee to endorse the recommendation of the Parliamentary Liaison Subcommittee on organizing a parliamentary visit to Canada and the United States (US) in February 2002.

#### **Background**

- 2. When considering the parliamentary liaison activities to be organized in the last session, the Parliamentary Liaison Subcommittee originally proposed to organize a visit to Canada and the United States (US) in April 2001. The destinations proposed were Toronto, Ottawa and Washington DC. The Subcommittee was of the view that a visit to Canada should be accorded a high priority because while various liaison activities had been organized with the respective friendship groups of Australia, Japan, Singapore and European Parliament in the past few years, the last visit paid by Members of the former Legislative Council to Canada had taken place in 1992. In order to optimize the value of the trip, the Subcommittee considered that the delegation to be formed should also make use of the opportunity to visit the US.
- 3. However, as the proposed timing of the visit was not convenient to Members of the Canadian Parliament and the Ontario Legislative Assembly, the Subcommittee eventually decided to defer making a recommendation on the proposed visit until a more suitable time.

#### The Subcommittee's recommendation

#### Details of the visit

- 4. The Subcommittee discussed the matter again at its meeting on 9 October 2001, after consulting the Canadian and US Consulates General regarding when their respective parliaments would be in session. The Subcommittee recommends that a visit to Canada (Toronto and Ottawa) and the US (Washington DC) should be organized to enhance the Council's ties with the Canada-Hong Kong Parliamentary Friendship Group, foster liaison with members of the US Congress, and to update them on the latest developments in the Hong Kong Special Administrative Region.
- 5. The Subcommittee proposes that the visit should last for nine days from 16 to 24 February 2002 during the Lunar New Year holiday break. It is intended that the programme will include meetings with parliament members and committees dealing with trade and commerce and international relations, as well as senior officials of the Canadian and US Governments, representatives of major overseas Chinese social and business communities, and other non-Government organizations. The assistance of the Hong Kong Economic and Trade Offices in Toronto and Washington will be enlisted in drawing up a detailed programme for the visit.
- 6. A draft budget for the proposed visit and a proposed flight and boarding schedule are attached in **Appendices I and II** respectively. Funds are available to cover the expenses of the visit.

#### The delegation

7. As approved by the Legislative Council Commission at its meeting on 20 February 2001, there will be eight fully-sponsored Members on a parliamentary visit. The selection of Members for joining the delegation will be conducted in accordance with the method set out in LC Paper No. CB(3) 339/00-01 agreed by the House Committee on 19 January 2001, i.e. Members are divided into six defined groups and the eight places are allocated among these groups on a pro-rata basis; each group of Members will decide its own way to nominate the participating Members

#### **Decision sought**

- 8. Members are invited to endorse the proposals in paragraphs 4 to 7 above.
- 9. Subject to Members' endorsement of the proposals, the Secretariat will make detailed arrangements, including liaison with the Consulates General, Hong Kong Economic and Trade Offices and the parliamentary offices concerned, as well as inviting applications from Members for joining the delegation.
