I Consideration of draft subsidiary legislation

LC Paper No. CB(1) 1564/01-02(01) Information paper provided by Administration Securities and **Futures** (Unsolicited Calls – Exclusion) Rules LC Paper No. CB(1) 1564/01-02(02) Information paper provided by Administration the on Securities and **Futures** (Licensed Persons and Registered Institutions) Information paper provided by LC Paper No. CB(1) 1564/01-02(03) Administration the Securities and **Futures** Counterparty) (Recognized Rules

Members agreed that the Subcommittee would scrutinize the English version of the draft subsidiary legislation. The Legislative Council (LegCo) Legal Service Division (LSD) was requested to examine the Chinese version of the draft subsidiary legislation and follow up with the Law Draftsmen on drafting and other technical matters. In the event that there were unresolved issues, LSD would raise them at meetings.

2. The Subcommittee deliberated (Index of proceedings attached at the **Annex**).

Admin 3. The Administration undertook to take follow-up actions as follows:

(I) <u>General</u>

to consider providing references to relevant provisions in the Securities and Futures Ordinance (SFO) in the title(s), margin or relevant clauses of the rule(s) to facilitate users in understanding the power and bases for making the rules.

(II) Securities and Futures (Unsolicited Calls - Exclusion) Rules

- (a) to review clause 2 on definition on "Monetary Authority guidelines" to clarify that the guideline refers to the guideline in force at the material time;
- (b) to amend clause 3(1) to the effect that section 174 of SFO will not apply to "any agreement to sell or purchase securities of a corporation to or from a person who is already the holder of securities of that corporation"; and

Action - 4 -

(c) to review clauses 3(3) and (4) to clarify that the purpose of subclause (4) is to provide some indications on "interactive dialogue" referred to in sub-clause (3)(c).

(III) <u>Securities and Futures (Licensed Persons and Registered Institutions)</u> Rules

- (a) to provide guidelines to be developed by the Hong Kong Monetary Authority (HKMA) for banks on provision of particulars of their staff engaging in securities business for inclusion in the register maintained by HKMA;
- (b) to consider whether a new set of subsidiary legislation should be made on information to be provided by applicants under section 128 of SFO:
- (c) to consider the appropriateness of the term "disciplinary action" in clauses 3(2)(g) and 3(3)(g) and whether such information should be included in the register if the disciplinary action is under appeal;
- (d) to consider specifying in clauses 3(2), (3) and (4) that particulars not spelt out in the rules would not be included in the register of licensed persons and registered institutions;
- (e) to consider developing procedures under clause 4 to minimize errors in putting information supplied by licensed persons and registered institutions into the register;
- (f) to review clause 6(1) and consider whether procedures should be developed for cancellation of licence when an intermediary or a licensed representative ceases to carry out the regulated activity;
- (g) to consider whether it is appropriate to extend clause 7(3)(e) to registered institution;
- (h) to consider providing guidance notes on criminal offences which are relevant to "fitness and properness" and hence required to be notified by licensed corporations under clauses 7(3)(h)(i), 7(4)(i)(i) and 7(5)(d)(i);
- (i) to review clauses 7(3)(h)(i), (iii), (v); 7(4)(i)(i), (iii), (iv) and 7(5)(d)(i), (iii) and (v) to ensure consistency in drafting; and
- (j) to review clauses 7(3)(l) and 7(4)(k) on the need to require information on changes in solvency status of associated entitles.

Action - 5 -

4. <u>Members</u> agreed that the Administration should provide revised versions on the three sets of draft rules for their consideration. The drafts should be circulated to members by the Secretariat. If members raised further issues, the Chairman would decide whether the revised draft rules should be discussed at meetings.

- 5. <u>Members</u> agreed to hold the next two meetings on **Thursday, 6 June** and **Friday, 7 June 2002 from 8:30 am to 12:45 pm**. The agendas for the meetings would be fixed in due course.
