Resolution Under Section 54A of the Interpretation and General Clauses Ordinance (Cap. 1)

Transfer of Statutory Functions from Secretary for Information Technology and Broadcasting to Secretary for Economic Development

Introduction

This paper sets out the transfer of statutory functions currently exercisable by the Secretary for Information Technology and Broadcasting to the Secretary for Economic Development with effect from 1 July 2002.

The Resolution

- 2. The introduction of the accountability system will be accompanied by the reorganization of a number of policy bureaux. As a result, the Secretary for Economic Development will be responsible for matters relating to economic services, information technology and broadcasting. The relevant statutory functions currently vested in the Secretary for Economic Services and the Secretary for Information Technology and Broadcasting will be transferred to the Secretary for Economic Development.
- Paragraph 4(a) of the draft Resolution provides that statutory functions currently exercisable by the Secretary for Information Technology and Broadcasting by virtue of the ordinances specified in column 2 of Schedule 4 to the Resolution be transferred to the Secretary for Economic Development. To give full effect to the Resolution, incidental, consequential and supplemental amendments, as appropriate, are introduced. Such amendments are provided for in paragraph 4(b) and Schedule 4 of the draft Resolution. Most of the amendments are to

replace references to "Secretary for Information Technology and Broadcasting" in the relevant ordinances with references to "Secretary for Economic Development". Paragraph 4 and Schedule 4 of the draft Resolution are attached at Annexes A and B respectively.

- 4. The opportunity is also taken to improve the definition clauses of one of the relevant ordinances. In the Film Censorship Ordinance, the definition of "Secretary" is only provided for in the English text. A corresponding definition would be added to the Chinese text.
- 5. A summary of the major statutory functions of the Secretary for Economic Information Technology and Broadcasting under existing legislation and the textual amendments to the relevant ordinances is attached as Annex C.
