## Resolution Under Section 54A of the Interpretation and General Clauses Ordinance (Cap. 1)

## Transfer of Statutory Functions from Secretary for Financial Services to Secretary for Financial Services and the Treasury

#### Introduction

This paper sets out the transfer of statutory functions currently exercisable by the Secretary for Financial Services to the Secretary for Financial Services and the Treasury with effect from 1 July 2002.

#### The Resolution

- 2. The introduction of the accountability system will be accompanied by the reorganization of a number of policy bureaux. As a result, the Secretary for Financial Services and the Treasury will be responsible for matters relating to financial services and public finances. The relevant statutory functions currently vested in the Secretary for Financial Services and the Secretary for the Treasury will be transferred to the Secretary for Financial Services and the Treasury.
- 3. Paragraph 8(a) of the draft Resolution provides that statutory functions currently exercisable by the Secretary for Financial Services by virtue of the ordinances specified in column 2 of Schedule 8 to the Resolution be transferred to the Secretary for Financial Services and the Treasury. To give full effect to the Resolution, incidental, consequential and supplemental amendments, as appropriate, are introduced. Such amendments are provided for in paragraph 8(b) and Schedule 8 of the draft Resolution. Most of the amendments are to replace references to "Secretary for Financial Services" in the relevant ordinances with

references to "Secretary for Financial Services and the Treasury". Paragraph 8 and Schedule 8 of the draft Resolution are attached at Annexes A and B respectively.

4. A summary of the major statutory functions of the Secretary for Financial Services under existing legislation and the textual amendments to the relevant ordinances is attached as Annex C.

5. Members are invited to consider paragraph 8 and Schedule 8 of the draft Resolution.
