# Resolution Under Section 54A of the Interpretation and General Clauses Ordinance (Cap. 1)

## Transfer of Statutory Functions from Secretary for Planning and Lands to Secretary for Housing, Planning and Lands

#### Introduction

This paper sets out the transfer of statutory functions currently exercisable by the Secretary for Planning and Lands to the Secretary for Housing, Planning and Lands with effect from 1 July 2002.

#### The Resolution

- 2. The introduction of the accountability system will be accompanied by the reorganization of a number of policy bureaux. As a result, the Secretary for Housing, Planning and Lands will be responsible for matters relating to housing, planning and lands. The relevant statutory functions currently vested in the Secretary for Housing and the Secretary for Planning and Lands will be transferred to the Secretary for Housing, Planning and Lands.
- 3. Paragraph 11(a) of the draft Resolution provides that statutory functions currently exercisable by the Secretary for Planning and Lands by virtue of the ordinances specified in column 2 of Schedule 11 to the Resolution be transferred to the Secretary for Housing, Planning and Lands. To give full effect to the Resolution, incidental, consequential and supplemental amendments, as appropriate, are introduced. Such amendments are provided for in paragraph 11(b) and Schedule 11 of the draft Resolution. Most of the amendments are to replace references to "Secretary for Planning and Lands" in the relevant ordinances with references to "Secretary for Housing, Planning and Lands". Paragraph 11 and Schedule 11 of the draft Resolution are

attached at Annexes A and B respectively.

4. A summary of the major statutory functions of the Secretary for Planning and Lands under existing legislation and the textual amendments to the relevant ordinances is attached as Annex C.
