**Resolution Under Section 54A of the  
Interpretation and General Clauses Ordinance (Cap. 1)**

**Transfer of Statutory Functions  
from Secretary for Commerce and Industry  
to Secretary for Commerce, Industry and Manpower**

**Introduction**

This paper sets out the transfer of statutory functions currently exercisable by the Secretary for Commerce and Industry to the Secretary for Commerce, Industry and Manpower with effect from 1 July 2002.

**The Resolution**

2. The introduction of the accountability system will be accompanied by the reorganization of a number of policy bureaux. As a result, the Secretary for Commerce, Industry and Manpower will be responsible for matters relating to commerce, industry and manpower. The relevant statutory functions currently vested in the Secretary for Education and Manpower and the Secretary for Commerce and Industry will be transferred to the Secretary for Commerce, Industry and Manpower.

3. Paragraph 1(a) of the draft Resolution provides that statutory functions currently exercisable by the Secretary for Commerce and Industry by virtue of the ordinances specified in column 2 of Schedule 1 to the Resolution be transferred to the Secretary for Commerce, Industry and Manpower. To give full effect to the Resolution, incidental, consequential and supplemental amendments, as appropriate, are introduced. Such amendments are provided for in paragraph 1(b) and

Schedule 1 of the draft Resolution. Most of the amendments are to replace references to “Secretary for Commerce and Industry” in the relevant ordinances with references to “Secretary for Commerce, Industry and Manpower”. Paragraph 1 and Schedule 1 of the draft Resolution are attached at Annexes A and B respectively.

4. A summary of the major statutory functions of the Secretary for Commerce and Industry under existing legislation and the textual amendments to the relevant ordinances are attached as Annex C.
